CALL TO ORDER

There being a quorum present, Mayor Hark called the meeting to order.

INVOCATION

Mayor Pro Tem Dexheimer gave the invocation.

PLEDGE OF ALLEGIANCE

Council Member Hatton led the Pledge of Allegiance to the Flag.

At this point, Mayor Pro Tem Dexheimer made a motion to excuse Council Member Wilson. Mayor Hark seconded motion.

Motion carried.

APPROVAL OF MINUTES Regular Meeting January 18, 2005

Council Member Hatton made a motion to approve the minutes. Council Member Green seconded motion.

APPROVAL OF PAYROLL AND CLAIMS Second Half of January 2005

Mayor Pro Tem Dexheimer made a motion to approve the payroll and claims. Council Member Hull seconded motion.

ANDY MORRIS – CITY MANAGER Re: Report on Proposed Lagers Update

Mr. Morris gave Council a brief description of an update that is available from Lagers. He explained that Lagers requires any update to be introduced before Council at least 45 days prior to adoption. He told Council that they would give this proposal more consideration when it came closer to budget time.

Re: Personnel Manual Update

Mr. Morris reminded Council Members that several weeks ago they were given a draft of the proposed revised personnel manual for their review. He asked that anyone with any questions or comments, please get back to him in the weeks to come, so that they could complete this project.

ROBERT CURTIS - CITY ATTORNEY Re: Warranty Deed to Apostolic Holiness Church, Inc.

(Resolution 1182 to follow)

Mr. Curtis asked Council to consider approving Resolution1182 to follow which would allow the Mayor to sign a warranty deed for property purchased by the Holiness Apostolic Church from the Board of Public Works.

MAYOR PRO TEM DEXHEIMER Re: Revisit Taxi License Denial for Steve Robertson

Mayor Pro Tem Dexheimer asked Council to reconsider their previous decision to uphold the Police Chief's denial of a taxi permit for Mr. Steve Robertson based on a past DWI felony conviction. He made a motion to allow Mr. Robertson to be granted a permit to drive a taxi within the City of Hannibal. Motion died for lack of second.

During a lengthy discussion, Council heard from both Mr. Steve Robertson and Mr. Terry Robertson, owner of the Taxi Company, regarding why they felt that a permit should be issued. City Attorney Robert Curtis also questioned Mr. Steve Robertson about whether he had been pulled over by the police last week and then cited for driving a taxi without a

permit. Mr. Robertson stated that he had misunderstood the appeal process and thought that it was all right for him to drive until the appeal had been heard before Council.

After more discussion between Council Members, Mayor Pro Tem's motion still stood without a second.

CHRIS STEINMAN – Y MEN'S ASSOCIATION Re: Summer Events

On behalf of the Y Men's Association, Mr. Chris Steinman requested Council's permission to close streets for mud volleyball and the Down by the River events. They made a request that the following streets be closed – Hill Street directly in front of the pavilion and the alley between the pavilion & Murphy Motors. Mud volleyball will take place from June 30th through July 3rd, 2005 and the Down by the River Events would be held from 4:00 p.m. to 9:00 p.m. on May 13th, June 10th, July 8th and August 12th.

Mayor Pro Tem Dexheimer made motion to approve the request. Council Member Knickerbocker seconded motion.

CATHY RAHE – TOURISM DIRECTOR Re: Brochure Distribution Bid Recommendations

Ms. Rahe presented four bids to Council that she had received for brochure distribution. Although Rachel & Lyndon Bode were the lowest bidders at \$8,000.00, she recommended that the bid be awarded to Virtual Images in the amount of \$8,325.00. She noted Virtual images had distributed the brochures up to this point and had done a very good job and therefore she felt that they deserved to be awarded the bid again because of their reliability and past service.

After several questions from Council regarding the decision, George Walley, Tourism Board member spoke to Council and gave a brief description of the services needed and why the Board had unanimously decided to stay with the present company (Virtual Images) even though they were not the lowest bidder.

Mayor Pro Tem Dexheimer made a motion to award the brochure distribution to Rachel & Lyndon Bode, who were the lowest bidders for the job. Council Member Green seconded motion.

JOHN WEALER – BUILDING INSPECTOR Re: Request to Purchase City Owned Property Located on Pine Street

Mr. Wealer brought a request to Council from Dino W. Wilson to purchase City owned property located on Pine Street. This vacant lot is attached to the backside of the two lots that Mr. Wilson presently owns known as 1501 and 1503 Bird Street and he would like to purchase this vacant land in order to keep it cleared. He agreed to pay \$100.00 plus recording costs for the property.

Mayor Pro Tem Dexheimer made a motion to approve the sale of this piece of property to Mr. Wilson.

Mayor Hark seconded motion.

During discussion, Mr. Wealer said that a deed would have to be drawn up and the Mayor would have to sign it. Mayor Pro Tem Dexheimer then amended his motion to approve the sale of the property and approve the Mayor to sign the deed.. Mayor Hark seconded the amended motion.

ROBERT CHRISCINSKE – GENERAL MANAGER OF BPW Re: Request to Waive City Ordinance in Regards to Use of Golf Carts on Roadways

Mr. Chriscinske asked Council to waive City Ordinance 17.116 which would allow Johnson Controls to utilize golf carts on the city streets in order to complete their project with the BPW for exchanging water meters. He asked that this be waived from the present, until such time as the project will be completed.

Council Member Knickerbocker made motion to waive Ordinance 17.116. This ordinance is to be waived from the present until April 15, 2005. Council Member Hatton seconded motion.
