## **Re:** Kids & Teens in Motion – Contract for Services

Douglass Community Services (Resolution No. 2101-17, to follow)

LaGarce then informed Council that the service contract with Kids & Teens in Motion has come up for renewal. This Resolution authorizes the Mayor to execute a \$7,500 Contract for Services with Kids-in-Motion/Teens-in-Motion. Every time some high-profile youth crime occurs in Hannibal, or serious act of violence or large-scale vandalism, LaGarce regrets the assailants hadn't been previously touched by KIM. If they had been, its highly-likely those crimes would never have been committed, and there would have been no loss or crime victims to be had. Resolution No. 2101-17, to follow.

# Re: Request Bid Waiver for Site Abatement on West Ely Road

LaGarce then informed Council that he is requesting a bid waiver for a project that has already been started. It has become larger than expected. There are decades of junk build-up and a large amount of overgrowth. LaGarce stated that there is no way to "tag" (for bid) the specific trees, branches, and vines that require removal, because it's "this tree", "that branch", "those vines". Restated, the scope-of-work is defined/redefined as they move forward and continue to clear excessive growth, where inspectors can now view what else is causing further obstruction, and requires removal. There is no logical way to bid this mess in any clear manner. It's now become clear the \$5,670 bid limit for service work will not hold here. This is not an open-ended check. Staff requests a bid waiver for this abatement project at 4109 West Ely Road, knowing full-well there are other abatement needs throughout the community that will arise during this fiscal year, and that costs should be kept as low as possible. Motion was made by Council Member Veach to approve the request. Motion seconded by Council Member Dobson.

## **BRIAN CHAPLIN – DPW SUPERINTENDENT**

Re: Alley Vacation – Minor Subdivision

(*Bill No. 17-017*, to follow)

Brian Chaplin, DPW Superintendent, informed Council that Ezra Blue and Sons appeared at the June 15th Planning and Zoning Commission along with Doug Walker, Surveyor from Janes Surveying asking for an alley vacation around their property at Lemon Street, Collier Street and Warren Barrett Drive. The Planning and Zoning Commission made a positive recommendation to approve the alley vacation to council. Along with the alley approval is a minor subdivision located at 1200 Collier, also owned by the Blue Boys and Sons, that is contingent upon approval. The lot now is three lots but is being asked to be combined into one lot. Staff recommends the approval of the Alley Vacation at Lemon Street, Collier Street and Warren Barrett; along with the Minor Subdivision at 1200 Collier for Ezra Blue and Sons. Bill No. 17-017, to follow.

# Re: Bid Award Approval – Utility Tractor and Boom Mower Arm Sydenstrickers

Chaplin then informed Council that on Wednesday, July 12, 2017 The Department of Public Works let bids for a Utility Tractor and a Boom Mower Arm. This tractor was originally bid on Thursday, June 22nd, 2017. There were two bids received and opened and read aloud. The first bid came in from Sydenstrickers in the amount of \$80,500.00. The second bid came from W.M. Nobbe in the amount of \$79,780.05. While W. M. Nobbe came in cheaper than Sydenstrickers, the Tiger brand rotary head is not warranted by John Deere. Sydenstrickers rotary head is part of a warranty covered package along with the John Deere tractor covered from front to rear which will be serviced locally. Staff recommends approval from council to accept the bid from Sydenstrickers in the amount of \$80,500.00 for the Utility Tractor and Boom Mower Arm. There was \$82,000 budgeted, so the bid still came in under budget. Motion was made by Council Member Dobson to approve the request. Motion was seconded by Council Member Veach.

Gail Bryant, Director of HCVB, informed Council that utilizing an outside advertising agency allows for all advertising invoices (from multiple vendors) to be paid through one vendor; which simplifies the process and gives additional benefits to research, advertising rates, oversight and tracking. Staff recommends utilizing the expertise and research capabilities of an outside advertising agency to receive the maximum return on our investment, in addition to remaining dedicated to our marketing strategy and promotion in targeted markets. The Hannibal Convention & Visitors Bureau (HCVB) would like to request bid approval with the state vendor, H&L Partners, for media buying in FY2018. The Hannibal Convention & Visitor Bureau solicited quotes to insure the best value. The state vendor has already met and passed the state requirements. The HCVB recommends the bid be awarded to the state vendor, H&L Partners for media buys on behalf of the Hannibal Convention & Visitors Bureau in FY2018. Motion was made by Council Member Van Hoose to approve the request. Motion was seconded by Council Member Welch.
