AN ORDINANCE OF THE CITY OF HANNIBAL TO CONTINUE THE APPLICATION AND COLLECTION OF THE LOCAL SALES TAX ON THE TITLING OF MOTOR VEHICLES, TRAILERS, BOATS, AND OUTBOARD MOTORS THAT WERE PURCHASED FROM A SOURCE OTHER THAN A LICENSED MISSOURI DEALER; AS APPROVED BY THE DULY QUALIFIED VOTERS DURING THE APRIL 7, 2015 MUNICIPAL ELECTION

WHEREAS, the City had not previously approved the application and collection of local tax on the titling of motor vehicles, trailers, boats and outboard motors, as provided for by RSMo. 144.020, which were purchased from a source other than a licensed Missouri dealer pursuant to requirements of RsMo. 32.087, and

WHEREAS, as provided for under the provisions of Section 32.087 RSMo, the City submitted to the qualified voters of the City the question of continuing or repealing the application of the local sales tax to the titling of motor vehicles, trailers, boats, and outboard motors that were purchased from a source other than a licensed Missouri dealer; and

WHEREAS, on April 7, 2015, the duly qualified voters of the City of Hannibal approved the continuation of the application and collection of local sales tax on titling of motor vehicles, trailers, boats and outboard motors (Proposition 2) during the Municipal Election, and the election results have been certified, thereof.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HANNIBAL, AS FOLLOWS:

SECTION ONE: Pursuant to the authority granted by and subject to, the provision of RSMo., Section 32.087, the City of Hannibal imposes the local sales tax **which continues the application and collection of** the titling of motor vehicles, trailers, boats, and outboard motors that are subject to state sales tax under section 144.020 and purchased from a source other than a licensed Missouri dealer.

SECTION TWO: This tax was submitted and approved by the qualified voters of the City of Hannibal, Missouri, as required by the provisions of RSMo. Section 32.087 at the municipal election call held in the City, Tuesday the 7th day of April 2015. The ballot submission contained substantially the following language:

NOTICE OF MUNICIPAL ELECTION
CITY OF HANNIBAL, MISSOURI

PROPOSITION 2

Shall the City of Hannibal continue applying and collecting the local sales tax on the titling of motor vehicles, trailers, boats, and outboard motors that were purchased from a source other than a licensed Missouri dealer?

Continuation of this measure will not result in a reduction of local revenue to provide for vital services for the City of Hannibal and it will not place Missouri dealers of motor vehicles, outboard motors, boats, and trailers at a competitive disadvantage to non-Missouri dealers of motor vehicles, outboard motors, boats, and trailers.

SECTION THREE: This Ordinance shall be in full force and effect from and after the date of its passage and approval.
