

**RESOLUTION NO. 2146-18**

**A RESOLUTION OF THE CITY OF HANNIBAL, MISSOURI AMENDING THE  
POLICEMEN AND FIREMEN RETIREMENT FUND, PLAN DOCUMENT  
SECTION 1.23 "YEAR OF SERVICE"**

**WHEREAS**, the City of Hannibal, Missouri ("City") sponsors the City of Hannibal, Missouri Policemen and Firemen Fund ("Plan"), and

**WHEREAS**, pursuant to Section 9.01 of the Plan, the Plan may be amended by the City from time to time, and

**WHEREAS**, effective July 1, 2016, the Council approved amended Section 2.02 – "*Employee Contributions*", in which Section 1.23 was inadvertently left out to reflect said amendment to contributions for payback purposes, and

**WHEREAS**, the proposed amendment will coincide with the specified rates for that particular time period, in accordance with Section 2.02.

**NOW THEREFORE, THE CITY OF HANNIBAL COUNCIL HEREBY AMENDS THE POLICEMEN AND FIREMEN PLAN DOCUMENT AS FOLLOWS:**

**SECTION ONE:** Effective retroactively to July 1, 2016, the City clarifies the last paragraph of **Section 1.23 – "Year of Service"** of the City of Hannibal, Missouri Policemen and Firemen Retirement Fund Plan Document to read as follows:

**"1.23 YEAR OF SERVICE"**

"Upon return from a leave provided above, said Member will be allowed a time period equal to three (3) times the length of uniformed service (or as otherwise provided in Code Section 414(u) or temporary total disability period, but not longer than five (5) years, to make-up contributions pursuant to Section 2.02 of the Plan that would have been made to the Plan but for the Member's leave. In the case of a Member returning after a period of temporary total disability, the Member's make-up contribution will equal a percentage of his or her temporary total disability payment during such period of disability, which percentage shall equal the percentage specified in Section 2.02 as in effect for the period of his or her disability. A Member on temporary total disability leave may elect to pay such contribution from his or her temporary total disability payment during the leave."

**AMENDMENT  
TO THE

**WHEREAS**, the City of Hannibal, Missouri ("City") sponsors the City of Hannibal, Missouri Policemen and Firemen Fund ("Plan"); and

**WHEREAS**, pursuant to Section 9.02 of the Plan, the Plan may be amended by the City from time to time;

**NOW, THEREFORE**, the City hereby clarifies the last paragraph of Section 1.23 of the City of Hannibal, Missouri Policemen and Firemen Retirement Fund to read as follows, such clarification to be retroactively effective to July 1, 2016:

"Upon return from a leave provided above, said Member will be allowed a time period equal to three (3) times the length of uniformed service (or as otherwise provided in Code Section 414(u) or temporary total disability period, but not longer than five (5) years, to make-up contributions pursuant to Section 2.02 of the Plan that would have been made to the Plan but for the Member's leave. In the case of a Member returning after a period of temporary total disability, the Member's make-up contribution will equal a percentage of his or her temporary total disability payment during such period of disability, which percentage shall equal the percentage specified in Section 2.02 as in effect for the period of his or her disability. A Member on temporary total disability leave may elect to pay such contribution from his or her temporary total disability payment during the leave."
