Effective March 1, 2020, City of Hannibal and Board of Public Works hereby amends the City of Hannibal and Board of Public Works Medical Benefit Plan, Plan Document and Summary Plan Description effective January 1, 2019, as follows:

The *Plan* will provide coverage for both testing, and services necessary to receive testing, for the condition related to the current public health emergency, without cost sharing.

Limited to the services outlined herein, this provision shall override any potentially conflicting, specific exclusions, defined terms, or other plan provisions for these services, as required to provide the mandated services for the public health emergency.

This shall remain in effect until the public health emergency, as declared by the Secretary of Health and Human Services (HHS), has ended.

All other terms and conditions of this City of Hannibal and Board of Public Works Medical Benefit Plan which are not affected by this amendment remain unchanged.

**Amendment No. 3**

Effective March 1, 2020, City of Hannibal and Board of Public Works hereby amends the City of Hannibal and Board of Public Works Medical Benefit Plan, Plan Document and Summary Plan Description effective January 1, 2019, as follows:

The Plan will provide treatment for the condition related to the current public health emergency with no cost sharing for *in-network* services.

The Plan will provide virtual visit services *related to the public health emergency* at no cost *in-network*. This includes services outside of any telemedicine vendor currently utilized by the Plan, if any.

The Plan will provide all telemedicine services at the standard benefit level through BeWell.

The Plan shall temporarily waive all pre-certification penalties for the period this amendment is effective.

Limited to the services outlined herein, this provision shall override any potentially conflicting, specific exclusions for these services.

This shall remain in effect until the public health emergency, as declared by the Secretary of Health and Human Services (HHS), has ended.

All other terms and conditions of this City of Hannibal and Board of Public Works Medical Benefit Plan which are not affected by this amendment remain unchanged.
