AN ORDINANCE OF THE CITY OF HANNIBAL REVISING CHAPTER 25, SEWERS AND SEWAGE DISPOSAL.

WHEREAS, the Hannibal Wastewater Treatment Plant (WWTP) is owned by the City of Hannibal and operated by the Hannibal Board of Public Works. The WWTP is a pure oxygen WWTP which operates under Missouri National Pollutant Discharge Elimination System (NPDES) permit number MO-0093513 (MSOP), and

WHEREAS, the City of Hannibal adopted its Pretreatment Program in 1992 along with an Enforcement Response Plan with local limits developed in 1995. Due to increases in flows and new operating permits issued since this date, and

WHEREAS, as part of the above referenced permitting and in conjunction with its Pretreatment Program, the City of Hannibal has been requested that it voluntarily make certain modifications to its existing ordinances regarding sewers and sewage disposal, and

WHEREAS, in response to such request, the City of Hannibal, in conjunction with consultants, and representatives of the Missouri Department of Natural Resources has promulgated certain changes to Chapter 25 of the Revised Ordinances of the City of Hannibal, and

WHEREAS, the Missouri Department of Natural Resources has reviewed the ordinances as drafted and has no objection to the form therein, and further have given public notice in accordance with the law, and have received no comment, adverse or otherwise in regard to the said ordinances, and

WHEREAS, the City Council believes that such ordinance revisions are in the best interests of the citizens of the City of Hannibal, as well as the interests of the parties receiving such services from the City of Hannibal, and that such ordinance revisions are necessary to enable the City of Hannibal to continue providing sewer service pursuant to its permit.

NOW THEREFORE BE IT ORDAINED, THE CITY COUNCIL HEREBY AMENDS CHAPTER 25 OF THE REVISED ORDINANCES OF THE CITY OF HANNIBAL AS FOLLOWS:

SECTION ONE: The city council hereby revokes CHAPTER 25 of the Revised Ordinances of the City of Hannibal, and enacts in its place a new chapter 25 as attached hereto as Exhibit "A".

SECTION TWO: It hereby is declared to be the intention of the City Council that each and every part, portion and sub-portion of this Ordinance shall be separate and severable from each and every other part, portion or sub-portion hereof and that the City Council intends to adopt each said part, portion or sub-portion separately and independently of any other part, portion or sub-portion. In the event that any part of this Ordinance shall be determined to be or to have been unlawful or unconstitutional, the remaining parts, portions and sub-portions shall be and remain in full force and effect.

SECTION THREE: All ordinances and parts of ordinances in conflict with this ordinance, in so far as they conflict, are hereby repealed.

SECTION FOUR: That this Ordinance shall be in full force and effect from and after its passage and approval.
