Re: Resolution Authorizing an Engineering Services Agreement with Cochran

Engineering for engineering and construction management related to the Palmyra

Road Sidewalk Project

Date: January 30, 2019

The City of Hannibal has been awarded a Transportation Alternative Program (TAP) Grant for design and construction of the Palmyra Road Sidewalk.

The staff have selected Cochran Engineering to be the design consultant, based on Cochran's knowledge of this project, the immediate project area, and their prior experience designing the previous portion of sidewalk along Palmyra Road. Further, Cochran has already designed a portion of this particular sidewalk extension as well, though some updating of that design is required (Gala Drive did not exist along Palmyra Road when the last segment of sidewalk was designed and built).

The agreement prescribes fees up to \$22,297.57 for the engineering and design portion, and up to \$32,588.30 for the construction management/inspection portion. Fees could be less, but per the contract, they cannot exceed these figures.

MoDOT, who will fund three-fourths of this project, has reviewed the Agreement, and provided approval.

Staff recommends approval of a Resolution authorizing the Mayor to execute an Engineering Services Agreement with Cochran Engineering in the amount of \$54,885.87 for design, engineering, and construction management services for the Palmyra Road Sidewalk.

Date: January 23, 2019

The city was awarded Transportation Alternative Program (TAP) Grant funding of \$298,456 for construction of Palmyra Road sidewalks. This project will continue the Palmyra Road sidewalk from Bay Avenue to Riverview Park.

The first step of this initiative is to execute a Program Agreement with the Missouri Highways and Transportation Commission. MoDOT requires this be done by Ordinance, rather than by Resolution.

The Agreement itself details project scope and location, reasonable progress, indemnifications, non-discrimination, right-of-way acquisition, assurance of sidewalk maintenance following completion, grant reimbursements, permitting, open financial records, and standard federal and state requirements.

Staff recommends first reading of an Ordinance authorizing the Mayor to execute a Program Agreement with the Missouri Highways and Transportation Commission for the \$298,456 TAP Grant.

The Hannibal Convention & Visitors Bureau is funded by overnight stays through the collection of lodging tax. The City of Hannibal's ordinance mandates the collection of lodging tax for the business of renting, leasing or letting living quarters, sleeping accommodations, rooms or parts thereof within city limits. In February of 2018, AirBnB announced an agreement with several states to collect applicable and agreed-upon taxes on behalf of their hosts. Through a voluntary collection agreement, AirBnB will collect the applicable taxes as outlined in the agreement for the City of Hannibal on behalf of their hosts. This is important to us because it will assist with the prevention of noncompliance. Several new lodging proprietors are unaware of the requirements.

Hannibal Convention & Visitors Bureau request that the City Council authorize the Mayor to enter into a voluntary collection agreement with AirBnB for the collection of lodging taxes and other applicable taxes as required by the City of Hannibal as outlined in the Agreement.

Appointment of New Escrow Agent

In February of 2005 the HBPW purchased customer territory from Ralls County Public Water Supply District No. 1. The terms of this purchase agreement called for the payment to be made over time with the purchase funds to be held in escrow. From the inception of this agreement to present time, the funds have been held by BNY Mellon and services by the St. Louis office of this firm. The representative on the account has been Mr. Kerry McFarland since 2005.

Mr. McFarland reached out to us recently to alert us that BNY was closing its St. Louis office and our account would be transferred to the Chicago office. Mr. McFarland is also changing employers and joining the Corporate Trust Department of Regions Bank. He invited us to move our account to his new firm.

We have been well served by Mr. McFarland and would like to keep our business in St. Louis. The BPW Board approved moving our account to Regions Bank at the January Board meeting on 1/21. Ralls County is also amenable to switching to Regions bank, and is in the process of getting their Board to approve.

There will be little or no cost to make the switch to Regions Bank, and we would like to continue working with a trusted professional familiar with our transactions. The transfer document does require the Mayor's approval.

Updated on Chloramine Alternative Project

Bids were opened on January 10th for the new Granular Activated Carbon Facility. These are the upgrades to the Water Treatment Plant process to allowing for us to discontinue the use of ammonia in the treatment process and still remain compliant with water quality regulations. The low bidder was River City Construction for \$8,461,000, and they were issued a notice of award on January 22nd.

To put the bid into context, the latest engineer's estimate was \$10.6 million for this portion of the project. I do want to be cautious about this news since many difficult to control items can occur during construction, but overall it is great news. Finishing construction on time and \$2 million under budget looks obtainable at this point and continues to be our goal.

Keep in mind; this portion of the project is for construction only and there are other capital costs associated with the project (engineering and the cost of the media are two examples).

Black and Veatch, our engineer, and River City have already begun working on a project schedule and taking care of typical construction contractual items. There is a preconstruction meeting in Hannibal on February 5th to kick off the construction portion of the project and discuss key details with the contractor.

Right after the bid opening we began working with our financial consultant (Joy Howard of WM Financial) to start preparations for selling bonds. We plan to sell \$10 million in municipal tax exempt bank qualified revenue bonds in about April of 2019, and pay for the remaining portions of the project out of the water department cash reserves.

Pilot testing of media options continues at the WTP. Our plan is to have bids with media suppliers in the calendar year 2019.

Brad Walden, a Hannibal resident who owns property at 208 and 210 North Street, had come before Council at the December 18, 2018 meeting asking for the City to deed him over a small piece of City property that is attached to his property.

There were no objections from any department within the City, especially since this lot sits next to a steep embankment making difficult for any buildable structures. The Board of Public Works did state that have a service pole and line feeding 210 N. Main. If they have continued access to maintain this pole and service, they are fine with the selling of this property. Mr. Walden is aware of the needed utility easement as well and stated that he would be more than willing to continue to give access to the Board of Public Works.

Mr. Walden was approved at council to take this piece of property to the Planning and Zoning commission and combine it with the lot next to it at 210 North Main as a Minor Subdivision as not to create an illegal lot. At the January 17th Planning and Zoning Commission meeting there was a unanimous approval to move forward with the combining of the lot at 210 North Street and the piece of property that Mr. Walden wishes to purchase.

Since the Minor Subdivision has been approved this is ready to come back to Council for approval of the final of the sale of the City lot. Mr. Walden will be purchasing the lot for \$500 plus the recording fees from the City.
