Dear Mayor Hark and Hannibal City Council Members:

The Hannibal Arts Council will proudly present the 43rd Hannibal Folklife Festival on October 19 and 20 in Downtown Hannibal. At this time, we would like to be placed on the City Council agenda to request and get approval for use of city streets for the event. Hannibal Arts Council staff will be glad to attend a City Council meeting in order to answer any questions. Please let us know which Tuesday we will be on the agenda and we will have someone there.

We would like to request permission and approval of the City Council to use the following area for the festival:

- North Main Street from Broadway north to North Street. PLEASE NOTE: HNB Bank closes their drive-thru on Saturday morning to allow us full use of the 100 block of North Main. Also, even though we request full use of the 400 block of North Main Street, we work with the Mark Twain Museum and keep their southernmost driveway open for pedestrian access and their northernmost drive-way open to allow motor coach and museum visitor access to their parking lot.
- Side Streets of Center, Bird and Hill to alleys east and west of Main Street to the alley. PLEASE NOTE: Even though we do not fully utilize side streets in each direction, we request this in order to keep side street parking a safe distance from the festival area.
- Main and Bird parking lot. This area is used for many purposes, including placement of dumpsters, portable toilets, etc. This area is also used for the use of the sale of alcohol by the Hannibal Arts Council, who will obtain all proper paperwork and permits for that purpose.

• Ole Planters parking lot. We typically only use the front half of this parking lot and no longer officially block it off. This area is used for limited vendor parking and dumpster placement.

Our Grounds Committee will block off the streets at 5:00 p.m. on Friday night and they will stay closed until 7:00 p.m. on Sunday. Downtown merchants and the Historic Downtown Marketing Council are aware of this request. We have more and more exhibitors who are requesting Friday evening set-up after 5:00 p.m. This certainly lessens the congestion on Saturday morning and so far has worked out without incident. Festival security is contracted for Saturday night. We also coordinate with the Hannibal Police Department, Street Department, Fire Department, Parks and Recreation Department, Downtown Merchants, and Board of Public Works for other festival issues and infrastructure needs.

Thank you, City of Hannibal, for supporting the Hannibal Folklife Festival from year to year. We truly appreciate the efforts!





Andy, Good to speak with you this morning. I look forward to working this out with you. Attached is the initial mural design as discussed.

I intend to paint the entire brick area. It will need to be power washed first but should be in good condition other than that. I decided to go with a Trompe L'oeil design which helps with all of the windows, wires and such. It means "fool the eye" which allows me to draw things that look like they are there when actuality they are not. Case in point, I will repaint an arched wall with lots of trim and carving. Through this wall is the actual scene. As discussed with the mayor, it includes the steamboat, Mark Twain and a young boy whistling and fishing who could be Tom, Huck or Sam Clemens. Because of all of the eagle nesting and viewings you have in the area I included a view of an eagle flying out of the scene into reality. This element will really bring the scene to life for the viewer. As I said, this is the initial concept layout. I'm not looking for art direction but looking for good suggestions regarding other elements or changes in content if necessary. I think it's important on this wall especially to promote the common sense of Hannibal history which of course includes the river, the boats and Mark Twain. This is only a photo composite used for discussion purposes. I will choose the colors and drawing style as I progress. A scene as this produced as a poster with Hannibal Missouri headline and the bicentennial dates should look very nice for the public.

RE: HMA Rehabilitation Project- Additional Services

With the street paving project winding down we were fortunate to be able to pave more streets then was originally planned for three years ago. As a result of the additional roads we have paved, PSBA had to incur additional paving inspection costs. These services included planning estimates, field inspections and documentation.

PSBA has submitted an additional engineering service agreement for the lump sum amount of \$10,000 to cover these additional costs. The original contract amount with PSBA was \$260,000.

The Department of Public Works recommends the City Council authorize the Mayor to sign an engineering service agreement with PSBA for additional services for the HMA Rehabilitation Project for the lump sum not to exceed amount of \$10,000.

SUBJECT: FYE 06/30/2019 and FYE 06/30/2020 Audit

As you are aware, the City is required to have an independent audit annually. The City is required to have an A-133 Single Audit (more depth and more sampling of data) because of the utilization of Federal and State Grants in excess of \$500,000 during the fiscal year.

In 2015, the City ran an advertisement in the Hannibal Courier Post for open proposals from qualified auditing firms and directly mailed RFP packages to six accounting firms from St. Louis, Columbia, and Springfield, Illinois. The City only received two quotes at that time and one "No Quote". In June, 2015, the Council adopted and approved Resolution #2001-15 awarding Wade Stables PC the contract for one year and at the City's option may be extended either one or two additional years (FYE 6/40/16 and FYE 6/30/2017).

This fiscal year will be the one year extension presented with resolution #2129.18 dated March 2, 2018 to continue with Wade Stables P.C. With the complicity of the City's outdated accounting system I would like to continue with Wade Stables PC while working on updating our financial software. I have been working the past three years to consolidate and streamline many of our accounts. I feel it would be very difficult to go through educating a new accounting firm when our goal is to improve and update this system. The software update was postponed this past fiscal year and has been budgeted for this current year.

I have received a letter to engage from Wade Stables PC for the FYE 2019 as follows:

I recommend and ask the Council to approve the following Resolution to extend the contract with Wade Stables PC for audit services for the City of Hannibal, Library, and Board of Public Works for the year ending June 30, 2019 and June 30, 2020.

Per the Government Accounting Standards Board statement number 75, all government entities are obligated to have an actuarial study done for the expected cost of all benefits other than pension benefits that are promised to employees to extend past the retirement of the employee. Specifically, this is intended to capture promised continued health insurance coverage costs.

GASB-75 requires the full liability to be recognized immediately on the balance sheet using the best estimated calculation of the present liability for future benefits by a third party certified actuary.

Lewis and Ellis (L&E) Actuaries & Consultants completed the GASB-75 study in the past and is familiar with the City's Self-Insurance program. The cost for this study of the City is \$2,700.

I recommend that the Council authorize the Mayor to execute and accept on behalf of the City, the engagement agreement for Actuarial Services with Lewis & Ellis. Resolution to follow.

## **Updated on Chloramine Alternative Project**

#### Pilot Testing

The 3<sup>rd</sup> Round of Pilot testing is nearing completion, and three carbons stood out and performed very similarly throughout the multiple pilot tests. The three best performing carbons will go through a bidding process in August. We are shooting for a three year contact with the chosen carbon supplier. Black and Veatch is in the process of writing a specification for bidders.

#### **Construction Update**

Construction on the new Granular Activated Carbon (GAC) Facility is well underway. After much anticipation and planning, our contractor broke ground on April 25<sup>th</sup>. The first large task was to perform an approximate 25 feet deep excavation near the existing Filter Building that was constructed in 1924. This excavation required extensive shoring to make the area safe for construction workers. The contractor completed the piling and foundation work for the new building as well as many of the concrete walls for the building's basement.

Due to an unusual amount of rain days, the contractor is slightly behind schedule at this point. I still believe the project will be substantially complete before the March 31, 2020 deadline.

Matt Munzlinger (BPW Utility Planning and Construction Engineer) will be at the Council meeting with some pictures and more details on the project.

#### **Background:**

In October, 2004 the HBPW purchased customer territory from PWSD #1 of Ralls County for \$1.5 million, with \$150,000 of the purchase price paid up front and the remainder paid out over a 20 year period per the terms of an Escrow Trust Agreement. The Agreement calls for semi-annual payments of \$33,750 commencing 7/1/2005 until the balance is paid off on 1/1/2025. There is no interest charged on the unpaid balance. All payments so far have been made and the unpaid as of today is \$405,000. The HBPW is required to fund the Escrow account with cash and securities valued in excess of the principal balance outstanding, and the account's most recent reconciled total balance was approximately \$594,000.

Several years ago the HBPW and PWSD #1 attempted to reach a mutually acceptable early payoff arrangement. However, negotiations were unsuccessful and were eventually terminated. Recently, the PWSD #1 reached out to us to see if we would entertain an early payoff off. The PWSD #1 is offering the HBPW an amount approximately \$65,000 less than the current principal balance. We have performed our own present value calculations and feel their offer is fair to the HBPW. By terminating the agreement early we can both save approximately \$65,000 on the outstanding principal balance and also free up approximately \$255,000 of reserves, which would be transferred to the Water Fund's unrestricted cash balance.

During the April Board meeting our Board accepted the PWSD #1 offer. Their legal counsel has prepared an amendment to the Escrow Trust Agreement to carry out the early payoff.
