

Dear Mayor Hark and Council Members,

In early July, we became aware that the Hannibal Municipal Court implementation of the Show Me Court system would have a significant impact on HPD. This change would require Hannibal Police office personnel to double enter all citations and complaints/summons into the Show Me Court system and our current Lawman records management system. On average 800 citations and hundreds of complaint/summons are generated each month that would need to be entered into both systems resulting in the need for additional personnel to accomplish this task.

In an attempt to find a more fiscally tolerable alternative, an electronic citation service was sought. During our research it was determined that the electronic citation service called DigiTicket (Saltus Technologies) was the only service provider that was compatible (interfaced) with both our Lawman records management system and the Show Me Court system.

A quote was requested and received from Saltus Technologies for their electronic citation services for an annual amount of \$16,819.00. Due to the interface issues, Saltus Technologies (DigiTicket) is a sole source provider and I ask your approval to waive the bid process established in the Hannibal City Charter Section 9.13 with a resolution to follow.

In addition to the electronic citation service, we will need to purchase in-vehicle computers or more commonly called Mobile Data Terminals (MDT). Not only would the MDT be used for the electronic citations but they would also allow for another communication avenue for the officers on the street and radio dispatchers to provide sensitive information directly to the officer instead of announcing it over the radio. Officers would also be able to complete reports while out on the street instead of coming into the police department.

A state bid quote was sought and received along with two other comparable quotes in accordance with Hannibal City Charter 9.13 (a)(6) and (c) for nine Panasonic TOUGHBOOK 55 14" Core i5 8365U – 8GB RAM 512GB Windows 10 Pro. The following are the quotes received:

Lori Rogers wishes to purchase 214 Division and 1413 Henry, lots that were acquired by the City from the Marion Countee Trustee thru a tax sale. Ms. Rogers resides at 215 Summit, which

is adjacent to both neighboring lots. If acquired Ms. Rogers plans to do an alley vacation thru Planning and Zoning to vacate the platted alley and then minor sub these two lots to her current property. The reason for her purchase of the lots is



for maintenance of her neighborhood. Currently, these lots are not maintained since the demolition of the homes other than mowed every few weeks. Ms. Rogers loves the idea of being able expand her yard and keeping her property and neighborhood clean, free of rodents, debris, and weeds, not to mention gaining two additional pieces of property for added value to her home.

In July, a letter report was ran to determine whether liens or other title clouds existed. The report suggests a clean title. The Council stipulated a \$500.00 sale plus recording fees on each lot and a Special Warranty Deed that states the following covenants:

COVENANTS AND RESTRICTIONS

Subject however, to the following covenants and restrictions:

- 1. The property shall be kept maintained in accordance with the requirements of applicable laws and ordinances. The property shall be kept mowed at a minimum to the standards established by ordinance. Any structures on the home shall be maintained in such a manner as to comply with all applicable ordinances, and under no circumstances shall they be allowed to reach the status of a common law public nuisance or a nuisance in violation of Hannibal City Ordinances.
- 2. The property shall be utilized on in accordance with the laws of the State of Missouri and the zoning ordinances of the City of Hannibal. No unlawful uses shall be allowed.
- 3. All taxes on the property, including federal, state, county or city shall be kept paid and current at all times.
- 4. These covenants and restrictions shall touch and concern the land, and shall be binding upon all subsequent title holders.

This Resolution would authorize the Mayor to execute the Transfer of Real Estate and Special Warranty Deed, with the sale price of \$500.00 plus recording fees for each lot.

Re: Street Vacation

Date: July 22, 2021

The City of Hannibal sent an application to the Planning and Zoning Commission asking for the

undeveloped platted street that is located next to the Old Baptist Cemetery to be vacated. This property is something that the City will never develop in the future and is considered only useful for a utility easement. According to the Hannibal Board of Public Works, there are no utilities that run thru this piece of land.



You will notice in the attached

photo highlighted in bold red, that the area in question is extremely overgrown and has not been maintained in a very long time. If this is vacated it will not landlock any other homes in the area, nor does the city have any intentions of opening this street in the future.

The City sent out letters to all property owners within 185 feet of this property informing them of the possible vacation and contacted the necessary departments within the City about the vacation. There were no objections from any departments. The Hannibal Board of Public Works stated there were no utility concerns at this location.

The Planning and Zoning Committee heard this request at their meeting on Thursday, July 15th, 2021. One neighbor who boarders the property was present to speak in favor of the request and one letter was received in objection of this request. Mark Bross with Klingler and Associates also reviewed the request for the vacation prior to the P&Z meeting, he too had no objections to the vacation of the street.
