SUBJECT: APRIL 2020 MUNICIPAL ELECTION

In accordance with the provisions of Section 17.01 Charter of the City of Hannibal, a general municipal election may be held for the purpose of electing a mayor, councilmen, and other elective officers of the city, and for the purpose of deciding any question which may lawfully be submitted to the electors.

At this time, I hereby request Council approval to give a first reading of *Bill No.19-022* which authorizes a Municipal Election to be held, Tuesday, April 7, 2020. The 2020 City of Hannibal Election schedule provides for the election of Council Members for the Fifth and Sixth Wards. These positions are currently held by Council Members Colin Welch and Jeff Veach, respectively, along with *Proposition R*.

Proposition R will allow the electors to decide whether to continue funding the City's Recycling Program by approving a recycling fee of \$1.90 (One dollar and ninety cents) per month, to be charged on each utility bill issued by the City of Hannibal Board of Public Works for service provided within the City limits of Hannibal, Missouri with said recycling services to be provided by a third party contractor, with preference granted to contractors providing meaningful, productive employment for people with disabilities. If adopted, this fee shall continue for a three year period to expire April 30, 2023.

Candidate filing for the above mentioned positions will commence Tuesday, December 17, 2019 at 8:00 a.m., concluding January 21, 2020 at 5:00 p.m.

The Hannibal Regional Airport is currently without an airplane mechanic. A mechanic is an extremely important part of a successfully ran airport. I was recently approached by Michael Geisendorfer who is an airplane mechanic in Quincy. Michael currently works on several Hannibal resident's planes in Quincy.

Michael has over 30 years' experience as an aviation mechanic and is looking to start his own business here in Hannibal. Michael would like to lease the City owned maintenance hangar at our airport to start his business, Lear Field Aviation, LLC. Michael would perform annual inspections, general aviation mechanics and sell aviation products such as oil and tires.

The Department of Public Works recommends a three year lease for \$1 per year followed by an additional three year lease for \$1 per year if both parties agree. Lear Field Aviation would be responsible for all utilities they use in the Hangar.

The Hannibal Fire Department is requesting permission to partner with the Missouri Department of Health and Senior Services for a sustainment grant for NARCAN (Naloxone HCl) Nasal Spray 4mg. NARCAN is currently being used by HFD first responders to combat opioid overdose emergencies.

HFD currently budgets for 10 units with 2 two doses per package (4mg per dose) annually. This sustainment grant would be at no cost to us after our first ten budgeted boxes and would replenish our stock after each use during an emergency.

HFD currently uses 8mg to 12 mg per emergency to reverse the effects during an opioid event. Feel free to contact HFD for additional information.

We would like to request bid approval for the purchase of office furniture at the new HCVB Office/Welcome Center. A legal notice was placed in the Hannibal Courier Post on September 13, 2019, and a Request for Proposal (RFP) was sent to the vendors requesting the information. The bids were opened on September 30, 2019, by the city clerk. The first bid was in the amount of \$25,466.88. The second bidder submitted three proposals. One for \$24,621.26, another for \$38,415.67, and a third option for \$50,371.83.

After further review, the HCVB Board agrees the lowest bid does not meet the requirements stated in the Request for Proposal (RFP) for the project. Also, the bid of \$25,466.88 is of comparable quality to the products in the second option of \$38,415.67.

The HCVB recommends the bid award to Golden Ruler, in the amount of \$25,466.88, for office furniture in the HCVB Office/Welcome Center.

2020 OFFICIAL HANNIBAL VISITOR GUIDE - DESIGN & LAYOUT

We would like to request bid approval for the layout & design of the 2020 Official Hannibal Visitor Guide. A legal notice was placed in the Hannibal Courier Post on September 12, 2019, and a Request for Proposal (RFP) was sent to the vendors requesting the information for the layout & design. The bids were opened on September 30, 2019, by the city clerk. We received two bids on the project. One bid of \$3,600.00, plus additional author alterations at a rate \$35.00 and omits copywriting. The other bid is \$4,500; proofing and copywriting for \$300; and photography/stock art for \$200, if applicable.

After further review, the HCVB Board agrees the lowest bid does not meet the requirements stated in the Request for Proposal (RFP) for the project.

The HCVB recommends the bid award to Next To Nothing Designs, in the amount up to \$5,000.00 for the design & layout of the 2020 Hannibal Visitor Guide.

2020 OFFICIAL HANNIBAL VISITOR GUIDE - PRINTING

We would like to request bid approval for the printing of the 2020 Official Hannibal Visitor Guide. A legal notice was placed in the Hannibal Courier Post on September 12, 2019, and an RFP was sent to the vendors requesting the information for the printing. The bid was opened on September 30, 2019, by the city clerk. We received a bid of \$22,220.00, plus estimated freight charges of \$1,525.00, plus \$20.00 per page for any author alterations.

The HCVB recommends the bid award to EP Graphics, in the amount of \$23,745.00, but not to exceed \$25,000.00 for the printing of the 2020 Hannibal Visitor Guide.
