An application was received from Shad Terrill to rezone the property located at 3700 Palmyra Road, Hannibal, Missouri. The rezoning request is to take the property currently zoned as E-Commercial and rezone it to B-Multifamily to build triplex and duplex buildings.

This request was sent to the City's consulting Engineer Mark Bross and per his report, there are properties to the east and to the southwest that are zoned A or B residential. Other properties to the west are zoned E-Commercial. Because the property would be zoned adjacent to an existing residential development, this would not be considered spot zoning. Also, the proposed use is consistent with the allowable uses under B-Multiple Family Zoning.

Four Points Land Surveying, the Surveying Company hired by Mr. Terrill submitted all the necessary paperwork in an enough time and all advertisements were made of the public hearing for the Planning and Zoning meeting that was held October 21, 2021, and for the Council meeting on November 2, 2021. Requests for proposals for all City entities were solicited for the City Depository, as defined in the City Charter Section 7.02, as the existing agreement between the City and F&M Bank & Trust Company is due to expire.

Two local banking institutions submitted proposals, both meeting the criteria defined in the City Charter and the Request for Proposals with two declinations. F&M Bank & Trust Company and HomeBank of Hannibal provided the responsive proposals

Both responsive proposals were qualified and able to offer the city with the services needed, including on-line banking, inbound and outbound wires and ACH's, payroll services, checking, money market accounts with checking, and a dedicated account manager. However, F&M Bank & Trust Company was able to provide all banking services at no cost/fees and provide a more competitive interest rate.

The Banking RFP committee comprised, of myself, Paul Trenhaile, Board of Public Works Finance Director, Phyllis Nelson, City Collector and Wesley Metz, Director of Finance, held a mandatory RFP submittal meeting and then met to review the responding RFP's.

It is the recommendation of the committee to award a two-year banking depository agreement with an option for automatic renewal for three (3) additional one-year consecutive terms between City and F&M Bank & Trust Company.

Sec. 7.02. - City depository.

The city depository shall be such bank or banks duly chartered under the laws of the State of Missouri or chartered under the laws of the United States and in either case doing business in the City of Hannibal as shall be designated by resolution of the council. The council shall provide by ordinance for the bonding of depositories. It may establish in addition to the general city fund and the light and water fund under the control of the board of public works such other funds as may be desirable and it may provide for the system of accounting to be used in connection therewith.
