RE: Truck Purchase and Vehicle Surplus

Due to the volatile nature of purchasing vehicles since Covid, the city is forced to make very quick decisions in order to place an order and get inventory reserved. This is very different than in years past when you had time to go out for low bid and select from different manufactures. Currently, only Ford is making commercial trucks and they are the only ones on State Bid with a very limited number of vehicles available.

With that said, we placed an order recently for the purchase of two 2024 Ford Maverick Trucks. Joe Machens Ford has the State Bid and each truck cost \$26,040, with a total price of \$52,080.

One of the Trucks will be used by the Recreation Department and the other truck will be split between the Parks/Street Maintenance Worker who cleans the park restrooms, City Hall and Street Department facility.

In a corresponding move, the Parks Department will surplus and sell;

- 2008 Dodge Durango with 116,484 miles
- 2008 Ford F-250, with 115,687

The Parks Department recommends utilizing the State Bid of \$52,080 for the purchase of two 2024 Ford Maverick Trucks from Joe Machens Ford as well as declaring surplus a 2008 Dodge Durango and 2008 Ford F 250.

2024 OFFICIAL HANNIBAL VISITORS GUIDE - DESIGN & LAYOUT

A legal notice was placed in the Hannibal Courier Post in August and an RFP was sent to vendors requesting the information for the 2024 Hannibal Visitor Guide layout & design. Bids were opened on September 11 at 10 AM by the city clerk. One bid was submitted by Phillips Media Group in the amount of \$4,800. One bid was submitted by McDonald Video & Photography in the amount of \$6,150.00. Both companies were verified by the city clerk's office and have Hannibal business liscenses.

We are one of the few CVB's in Missouri who still do a Visitor Guide - including ad sales - in-house in order to keep the ad prices accessible to our tourism partners. Outsourcing the guide to a company would mean many of our locally owned businesses would not be able to afford ads.

The last 7 months have seen much turnover in CVB staff. Both full-time staff have changed; one full-time position is not yet filled. This leaves no one on staff that has gone through the very involved process of selling ads, proofing editorial and ads and working with a design company to ensure a quality product and seamless delivery to the printing company. It

While Phillips Media Group came in with a lower bid, they have no history of working on this project. If the CVB were fully staffed with at least one employee that had gone through this process before, it would not be an issue. That is not the case. McDonald Video and Photography has successfully put together the Hannibal Visitor Guide for three years and has streamlined the process and knows what is involved. At this point, the company is more familiar with the visitor guide process than the current CVB staff.

Due to extenuating circumstances, the HCVB respectfully recommends the bid be awarded to McDonald Video & Photography in the amount of \$6,150.00 for the layout & design of the 2024 Hannibal Visitors Guide.
