There being a quorum present, Mayor Hark called the meeting to order.

INVOCATION

The invocation was then given by Council Member Cogdal.

PLEDGE OF ALLEGIANCE

Mayor Hark then requested Police Corporal Borgmeyer to lead the Pledge of Allegiance to the Flag.

LINDA STUDER – HISTORIC HANNIBAL MARKETING COUNCIL Re: Request, Street Closures, Use of City Owned Property, Sale of Alcohol on City Owned Property & Discharge of Firearms (blanks) – Twain on Main (May 28th – 4:00 p.m. – May 30th – 5:00 p.m.)

Mayor Hark requested Linda Studer, representing the Historic Hannibal Marketing Council to come forward to present her request. City Clerk Zerbonia requested to present the request on Studer's behalf, due to her not being present. Zerbonia stated HHMC is requesting street closures, use of City owned property, the sale of alcohol on City owned property and the discharge of firearms (blanks) for the annual Twain on Main. This event is scheduled to be held May 28th, beginning at 4:00 p.m. through May 30th, 2021 at 5:00 p.m.

Zerbonia stated the certificate of insurance and hold harmless agreement is on file, and the requests are similar to what was requested in past years. Mayor Hark stated since this is not a "new" event, if the Council pleases, they can still approve HHMC's request for Twain on Main allowing Zerbonia's presentation.

A motion was made by Mayor Pro Tem Dobson to approve the requests of street closures, the use of City owned property, the sale of alcohol on City owned property and discharge of firearms (blanks) for the annual Twain on Main event to be held on May 28th, beginning at 4:00 p.m. through May 30th, 2021 at 5:00 p.m. The motion was seconded by Council Member Welch.

Peck's last item is more of a house keeping item. She stated this is an update to the City Code, Chapter 14, *Human Rights and Human Relations*, Article II – Affirmative Action Committee. It was discovered this Ordinance had not been updated in quite some time. She and the City Attorney worked on the updates, which include meeting on an as needed basis and at least annually.

Mayor Hark stated Bill No. 21-005 is to follow, for a first reading.

ANDY DORIAN – DIRECTOR, CENTRAL SERVICES Re: Riverfront Restoration Project – Change Order No. 6

Bleigh Construction Company - \$36,455.12 (Resolution No. 2318-21, to follow)

Andy Dorian, Director of Central Services, approached Council, with two items. His first item being approval of Change Order No. 6 for the Riverfront Restoration Project, which is an "addon" to the project. Dorian advised as part of Phase 2 of the Project, they are requesting approval with the change order to install an ADA accessible kayak launch, inside the Marina.

Kayaking has increasingly grown in popularity in Hannibal and around the country. Having a designated kayak launch allows patrons to enter and exit the water more safely. The ADA component will allow patrons with mobility issues the opportunity to safely enter and exit a kayak so they can enjoy being out on the water. Having an ADA kayak launch will be a great addition to the riverfront for both our local citizens and for people coming up and down the river.

Dorian advised the total cost for the installation of the ADA kayak launch is \$36,455.12. If approved, the kayak launch will be installed later this spring. Dorian also advised he expects one more change order, for the dock configuring and electrical work in the Marina, which he anticipates being the last one so the project can then be closed.

Mayor Hark stated Resolution No. 2318-21 is to follow, for approval.

Re: Aquatic Center Slide Restoration Project – Proposal Contract & Notice of Award

Baynum Painting - \$47,380 (Resolution No. 2319-21, to follow)

Dorian's last item is approval of the contract for the Aquatic Center Slide Restoration Project. Dorian stated bids were let with two received. Baynum Painting submitted the low bid in the amount of \$47,380, which includes a \$20,000 contingency. The reasoning for the contingency is due to the company being "off-site" and dealing with fiberglass. There may be other projects the company or the City would want them to complete, therefore, contingency would cover those expenses.

Dorian stated Resolution No. 2319-21 is to follow, for approval.

Mayor Hark questioned the age of the slide, in which Dorian advised he was not exactly sure but believed it was bought in early 2000's. Dorian advised he had engineers evaluate the equipment and everything was found to be in good condition. The "red" slide was recoated last year, and this renovation will complete all restorations and renovations to the Aquatic Center equipment. It should be several years before any restoration will be needed, once this project is completed.

Mayor Pro Tem Dobson asked Dorian if he is planning to open the pool this year, due to the pandemic still going on, in which he replied that is the current plan. In fact, the Parks & Recreation Department just held a job fair for staffing of the aquatic center.
