ANDY DORIAN – DIRECTOR OF CENTRAL SERVICES Re: Huckleberry Tennis & Pickleball Court Renovation Bid Award

(Resolution No. 2446-23, to follow)

Andy Dorian, Director of Central Services first item this evening is a bid award to Byrne and Jones of St. Louis for the renovations to the Huckleberry Park tennis and pickleball courts. Mr. Dorian advised the Council the City had received one bid in the amount of \$334,900.00. Mr. Dorian explained the bid would cover the demo of old courts, re-asphalt surfacing, painting, and sealing new courts, new poles and nets for the tennis and pickleball courts, new fencing, re-grading of the viewing area for bleachers, and construction of a new parking area. Mr. Dorian advised if the bid is accepted the project will begin in March of 2023 with a timeline of 120 days (about 4 months), additionally the project had been budgeted for the 2022-2023 fiscal year.

Andy Dorian, Director of Central Services second item tonight is an engineering service agreement between the City of Hannibal and Klinger & Associates in the amount of \$9,000.00. Mr. Dorian advised the Hannibal Parks and Recreation Department has been awarded a \$100,000.00 Land

Conservation Partnership Grant for the construction of a pavilion at Sodalis Nature Preserve, Mr. Dorian explained the grant is a 50/50 match for the project.

Andy Dorian, Director of Central Services third item tonight is a three-year lease between the City of Hannibal and Airplane Mechanic Michael Geisendorfer (Lear Field Aviation, LLC), in the amount of \$1.00, also including an option for an additional three-year extension. Mr. Dorian advised Mr. Geisendorfer has thirty years' experience, brings pilots into Hannibal for maintenance on aircraft, purchasing fuel, and patronizing local businesses. Mr. Dorian advised he is an asset to the airport and assists the city with maintenance projects free of charge.
