INVOCATION

The invocation was then given by Mayor Pro Tem Dobson.

STEPHANIE COOPER – HANNIBAL EARLY BIRD KIWANIS Re: Pork Chop Dinner Fundraiser

Friday, May 12, 2023, 8:00 a.m. until 7:00 p.m. Friday, September 8, 2023, 8:00 a.m. until 7:00 p.m.

Stephanie Cooper, representing Hannibal Early Bird Kiwanis, approached the Council requesting street closures and no parking signs for the upcoming pork chop dinner, fundraiser. The first event is planned for Friday, May 12th with the second event to be held Friday, September 8th from 8:00 a.m. to 7:00 p.m. for their pork chop dinner. Mayor Hark then called Anthony Viorel, representing AVK Events, LLC forward. Mr. Viorel advised Council he is requesting a caterer's license for an event to be held at The Orchard located at 2200 Palmyra Road, held on Saturday, April 22, 2022, from 5:00 p.m. until 10:00 p.m. This area is not zoned for the sale of alcohol, thus requires Council approval.

Council Member Welch made a motion to approve the issuance of the caterer's license for AVK Events to sell alcohol at The Orchard, Saturday, April 22nd from 5:00 p.m. until 10:00 p.m. The motion was seconded by Mayor Hark.

Mayor Hark called Jim Van Hoose forward. Mr. Van Hoose advised the Council he would like to discuss his support of a City Managers report. Mr. Van Hoose advised Managers Reports can be short or long and placed on the City website for the convenience of the community.

ALAN BOWEN – 13394 OLD HIGHWAY 79 Re: Support of City Manager Report

JAMES LEMON – CITY ATTORNEY Re: Ordinance Revising Chapter 2, Article III, Section 2-172

City Attorney James Lemon advised Council Members Franke and Phillips had requested he look at a proposal they drafted asking that an Ordinance be developed and passed requiring the City Manager present a monthly City Managers report during one of the two regularly scheduled Council proceedings of each month. Mr. Lemon said he had reviewed the documents and Bill number 23-008 would follow later in the meeting.

JESSICA ROSENKRANZ – FISCAL MANAGEMENT ASSISTANT Re: Present 5-Year Capital Improvement Plan 2024-2028

Jessica Rosenkranz, Fiscal Management Assistant presented the Fiscal Years 2024 through 2028 Capital Improvement Budget to Council for approval. Ms. Rosenkranz advised the Council that Deputy City Clerk Cogdal has provided a copy of the new Capital Improvement Budget for their review and any questions or concerns could be addressed.

MEGAN RAPP – DIRECTOR OF CONVENTIONS & TOURISM Re: HCVB Contract for Website Development with OBP Agency

Nicole McKee Sales Manager for Hannibal Convention and Visitors Bureau was next to address Council. She advised it was time to award the bid for the new website. Ms. McKee advised bids were taken and the winning bid in the amount of \$105,000.00 was received from Osborn Barr Paramore (OBP.) Ms. McKee reminded the Council seventy-five percent of the cost will be reimbursed by the State Marketing Platform Development Grant, and the project should be completed by June 15, 2023.

JACOB NACKE- CHIEF OF POLICE Re: Bid Approval High Threat Ballistic Vests

\$9,745.40 Law Enforcement Block Grant Funding & \$15, 918.00 Police Department Funding

Alex Grote, representing the Hannibal Police Department, advised Council the Hannibal Police Department is asking for a bid approval to purchase ten high threat ballistic vests. Lt. Grote advised the vest currently used by officers are past their rated expectancy, and the new vest will be lighter and rated to stop high threats including shotgun rounds.

Lt. Grote reminded Council the Hannibal Police Department received a grant from the Local Law Enforcement Block Grant that will cover \$9,745.40, with the remaining \$15,918.00 paid from the current department budget.

Mayor Pro Tem Dobson made a motion to approve the bid from First Spear, LLC in the amount of \$25,663 for the purchase of ten high threat ballistic vests. Council Member McCov seconded the motion.

Re: Bid Approval Unmanned Aerial System

Unmanned Vehicle Technologies \$18,043.50

Jennifer Grote, representing the Hannibal Police Department, advised Council the Hannibal Police Department is asking for bid approval for the purchase of an unmanned aerial system commonly referred to as a drone. Lt. Grote advised the low bid in the amount of \$18,043.50 was received from Unmanned Vehicle Technologies. Lt. Grote advised Council the cost of the equipment will be covered by several donations from local agencies including \$9,500.00 from Continental Cement/Green America, \$3,000.00 from Norfolk Southern Railroad, and \$3,049.79 from Marion County Law Enforcement Foundation Grant, leaving the amount of \$2,493.71 to be covered by the Hannibal Police Departments investigative fund.

Council Member Veach made a motion to approve the bid from Unmanned Vehicle Technologies in the amount of \$18,043.50 for the purchase of the drone. Mayor Pro Tem Dobson seconded the motion.

ANDY DORIAN – DIRECTOR OF CENTRAL SERVICES Re: Bid Approval for Sale of "Old Dog Pound"

High Bid- Jeff Barton \$35,000.00 (Resolution No. 2449-23, to follow)

Andy Dorian, Director of Central Services, first item this evening is the approval of the bid for City owned property at 2923 Warren Barrett Drive known as the "Old Dog Pound" in the amount of \$35,00.00 to Jeff Barton. Mr. Dorian advised the City received one bid and it was \$2,000.00 over the minimum bid amount placed by Council.

Dorian's second item tonight is a request to enter into a State Block Grant Agreement in the amount of \$289,381.00 with Missouri Highway and Transportation Commission for the funding of the terminal renovations. Dorian advised the project had previously been approved by Council, however this agreement allows the City to receive funding from the Missouri Highway and Transportation Commission for the terminal renovations and drainage repairs at the Hannibal Regional Airport. Mr. Dorian advised the project is scheduled to begin April 20, 2023
