Mayor Pro Tem Mike Dobson advised the Council with the decision to increase City employees' wages by 10% in the Fiscal Year 2023/2024 budget the City will need to seek additional revenue sources to meet the increase in wages benefits, and retirement contribution increases. Mr. Dobson proposed seeking an increase in personal property tax rates in the amount of 10%. Mr. Dobson advised personal property tax rates for the City of Hannibal had not been increased since the 1970's and would generate approximately \$262,000.00 that would help bridge the gap in the budget deficit with the upcoming 10% increase.

Council Member Phillips advised that he, and Council Member Franke would like to propose for the 9<sup>th</sup> time an Ordinance instructing the City Manager to prepare and present once-a-month, a report highlighting items the City Manager deemed appropriate during a regularly scheduled Council Meeting, Mr. Phillips, advised that the report would take up less than 10 minutes of time to showcase staff whom often go above and beyond in their service to the City.

Mr. Franke advised that funding is a long-term problem that has more than one correct solution, advising before being placed on the ballot the Missouri Legislature must give permission, hire a lobbyist, and secure a sponsor to pre-file the Bill. Mr. Franke advised with the ½ cent sales tax 40% of the revenue would be earned by non-residents.
