#### Re: City Manager Employment Agreement

(Resolution No. 2352-21, to follow)

Mayor Hark then advised Resolution No. 2352-21 is to follow for approval which is the employment agreement between the City and Lisa Peck, City Manager.

#### LISA PECK – CITY MANAGER

Re: Hannibal Regional Airport Runway Light Replacement Project – MoDOT Application for Federal /State Assistance

\$638,118 (Resolution No. 2353-21, to follow)

Lisa Peck, City Manager advised she is requesting, on behalf of Andy Dorian, Director of Central Services, approval to apply for a Missouri Department of Transportation (MoDOT)

Aviation Grant for the replacement of runway lights, Precision Approach Path Indicators (PAPI) and Runway End Identifier Lights (REIL) at the Hannibal Regional Airport.

She advised that currently the runway lights are out of compliance due to the height and age. In addition, the PAPI's and REIL's are at the end of their useful life and are suffering consistent failures. The cost estimate, provided by the City's Aviation Engineering Firm, Jviation, is \$690,500 to conduct this project.

This grant, if awarded, is a 90/10 cost share which breaks down as follows: \$638,118 - Federal Funding \$52,383 - City Funding

Peck advised the City has approximately \$660,000 in Aviation Non-Primary Entitlement Funding for this project which covers the 90% portion.

Mayor Hark stated Resolution No. 2353-21 is to follow, for approval.

#### ANGELICA ZERBONIA – CITY CLERK

Re: Request, Set Public Hearing - USDA Rural Development Grant Application

MOSWIN Radios - Police, Fire & Building Inspection Departments

(Tuesday, August 3, 2021 – 6:30 p.m.)

Angel Zerbonia, City Clerk advised she has two items to present with her first item being a request to set a public hearing regarding the City's intent to apply for a funding through the United States Department of Agriculture (USDA), Rural Development grant process for the purchase of MOSWIN radios for the Fire, Police and Building Inspection Departments.

Zerbonia advised, Council previously held a public hearing for this same issue on July 6<sup>th</sup>, however, the mandatory 10-day publication requirement was not met. The legal notice for the public hearing was published in the local newspaper six days prior to the hearing, therefore, USDA is requiring Council to hold the hearing, meeting the 10-day publication requirement. She did verify with USDA that there was no need for Council to reapprove the grant application and they were continuing to proceed through the grant application process, providing the necessary financial data, equipment needs justification and quotes.

The subject of the meeting is to again make the public aware of the City's application to USDA Rural Development for financial assistance in the purchase, from the City's general fund, of MOSWIN radios for Police, Fire and Building Inspection Departments.

A motion was made by Mayor Pro Tem Dobson to set a public hearing at 6:30 p.m. on Tuesday, August 3, 2021, notifying the public the City's intent to apply for financial assistance through the USDA Rural Development to purchase MOSWIN Radios for the Police and Fire Departments along with the Building Inspector's office. The motion was seconded by Council Member Veach.
