SARA ROTHWEILER – HANNIBAL JAYCEES

Re: Request, Street Closure – Annual Christmas Parade Saturday, December 7, 2019 – 5:00 p.m. – 7:00 p.m.

Sara Rothweiler, representing the Hannibal Jaycees, approached Council requesting street closures for their annual Christmas Parade to be held Saturday, December 7th, from 5:00 p.m. to 7:00 p.m. She stated the parade will begin by lining up at Save-a-Lot parking lot, will continue down Broadway, turning left on Main Street, ending at North Street. She is requesting all side streets to be blocked along the parade route as well.

Mayor Hark stated the hold harmless and certificate of insurance have been received, he does request trash to be cleaned up after the event.

Council Member Bowen asked what the theme is this year, in which Ms. Rothweiler stated it is Disney Winter Wonderland. She also stated, just like in previous years, they are collecting toys for the Toys for Tots program.

A motion was made by Mayor Pro Tem Dobson to approve the street closure request for the annual Christmas Parade, sponsored by the Hannibal Jaycees, to be held Saturday, December 7, 2019 from 5:00 p.m. to 7:00 p.m. The motion was seconded by Council Member Bowen.

CHRIS BROWN - Y MEN'S CLUB OF HANNIBAL

Re: Request, Street Closures – Down by the River & Mud Volleyball Events

*DBTR – May 15, June 19, July 17, August 21, September 18, 2020

*Mud Volleyball – July 2 – July 5, 2020

Chris Brown, representing the Y Men's Club of Hannibal approached Council requesting street closures for Down by the River events for the following dates:

- May 15, 2020
- June 19, 2020
- July 17, 2020
- August 21, 2020

He also requested street closures for the annual Mud Volleyball tournaments held during National Tom Sawyer Days that will be taking place July 2 – July 5, 2020.

Mayor Pro Tem Dobson questioned the issue of North Street, in the event re-construction is still being done, in which Mr. Brown advised they can work around whatever area is currently blocked off, if any area is, and just like last year they can re-locate the showers to Hill Street.

Mayor Pro Tem Dobson then brought up the issue of possible reserved handicap parking, however, he did not see the request for parking for this event. City Clerk Zerbonia concurred this was not a part of the request and not normally done so for these events, therefore no issues.

The street closures he is requesting include the alleyway west of the Y Men's Pavilion and Hill Street from Main Street to the floodwall.

A motion was made by Council Member Welch to approve, pending the certificate of insurance being on file, the requested street closures for the dates listed above for the Y Men's Down by the River and Mud Volleyball events. The motion was seconded by Mayor Pro Tem Dobson.

LISA PECK – CITY MANAGER Re: Update, Code Enforcement & Permitting Software Purchase

City Manager Peck updated Council on the code enforcement and permitting software purchase, in which she stated it was approved by Council during the last meeting, pending the contract. However, a contract will not be necessary because the City will be using the state bid contract. Some costs will be ongoing, and she will plan to re-negotiate every year.

Council Member Cogdal questioned, when Peck thought the software would be in place, in which Peck advised she is hoping by the first of the year, however they probably won't have all the "bugs" worked out and completely operational until February, 2020.

Mayor Pro Tem Dobson suggested it might be a good idea for Peck to discuss the GIS and the sharing of information with 911 next week during their scheduled meeting.

Council Member Cogdal asked what was going to be done with permit and paperwork from the past. Peck stated, as time permits, she would like to see the previous paperwork uploaded into the data base. The main concern now is to get the software up and working; this could perhaps be a project for an intern at some point.

GAIL BRYANT – DIRECTOR, HANNIBAL CONVENTION & VISITOR'S BUREAU Re: Approval, Bid Waiver for Media Buys

Gail Bryant, Tourism Director, approached Council requesting a waiver for bids for media buys to complete the fiscal year 2020 spring ad campaign. Bryant advised that as of August 31, 2019, H&L Partners are no longer the Missouri Division of Tourism's (MDT) agency of record and their contract expired. After vetting the new state vendor agency, the HCVB Board decided to revisit consideration of their services next year, in order to allow them time to develop a history with the state media buys.

In order to continue the marketing plan, Bryant is requesting Council to approve the HCVB to utilize up to \$75,000, which is "ear marked" in line item #48.569, in the FY 2019/2020 budget. If approved, the vendors would be: Carr Strategies, Facebook, KC Royals, Lamar Advertising, Next to Nothing Designs, Madden Media, Meredith Travel Marketing, Miles Media, Missouri Meetings & Events, NPR, Pandora Radio, Poole Communications, Spotify Radio, Quincy Broadcast, Sinclair Broadcast Group, Spectrum Reach, St. Joseph News Press, St. Louis Cardinals, and YouTube. With the HCVB utilizing those media buys direct, it could produce a cost-savings of up to \$11,250.00 in fees.

A motion was made by Mayor Pro Tem Dobson to approve the request for bid waiver for media buys for the HCVB. The motion was seconded by Council Member Bowen.
