#### SARA ROTHWEILER – HANNIBAL JAYCEES Re: 68<sup>TH</sup> ANNUAL NATIONAL TOM SAWYER DAYS

Street Closures, Parade, Carnival, Fence Painting, and Beer Garden Use of City Owned Property (Armory Parking Lot) Friday, June 30<sup>th</sup>, 2023, until Tuesday, July 4, 2023

Council Member Jeff Veach, representing the Hannibal Jaycees, presented in place of Sara Rothweiler, is requesting street closures for the upcoming 68<sup>th</sup> annual National Tom Sayer Days events for the following dates; Tuesday June 25, 2023 until Wednesday July 5, 2023. He is requesting barricades be placed at Lyon Street, under the viaduct, and South Main Street, at Lyon and Main Street next to flood wall, and at the corner of Lyon and South 4<sup>th</sup> Street, in addition to east of the viaduct at Church Street alley. #### **Re: Bid Approval Emergency Vehicles**

Police Emergency Vehicles/Fire Vehicle \$791,361.20

Jacob Nacke, Hannibal Police Chief, advised Council the Hannibal Police Department had solicited bids for the purchase of twelve emergency vehicles to replace an aging fleet previously purchased in 2018. Nacke advised the City received one bid in the amount of \$791,361.20 from Karl Emergency Vehicles of Des Moise, Iowa. Chief Nacke advised the current timeline for delivery would be at the beginning of the new fiscal year.

Council Member Veach made a motion to approve the bid from Karl's Emergency Vehicles in the amount of \$791,361.20 for the purchase of twelve new emergency vehicles. Council Member Welch seconded the motion.

#### Re: 2023 American Rescue Plan Act, State and Local Fiscal Recover Funds, And Peace Officer Grant Award Documents

Award Documents- \$19,425.93

Nacke's advised the Hannibal Police Department applied for and was awarded the American Rescue Plan Act, State and Local Fiscal Recover Funds, And Peace Officer Grant in the amount of \$20,000.00 for the purchase of new computers and associated equipment. Nacke advised this is a 50% matching fund grant and the total cost of the project will be \$38,851.86.
