BIANCA QUINN – FINANCE DIRECTOR

Re: 2023 Ad Valorem Property Tax Levy

Phyllis Nelson, City Collector advised the Council she is standing in for Bianca Quinn to present the Marion and Ralls County 2023 aggregate assessed valuations. Ms. Nelson advised the City is to hold a public hearing and approve an Ordinance by Council, which will adopt the proposed tax rate, as approved by the State Auditor, which is based on prior years tax information. Ms. Nelson advised the General Fund rate is set at 0.7590, Library 0.2854, and Police and Fire Retirement at 0.1334. The State adjusts rates are to allow for inflation, increases in assessed values, and depreciation. Ms. Nelson advised that due to time constraints she is asking for an emergency reading to the Ordinance as presented.
