# **BOB YAPP & ANDREW WIKSTROM – CITIZENS Re: Derelict Houses in Downtown Neighborhood**

Bob Yapp, accompanied by Andrew Wikstrom, addressed the Council regarding the derelict properties in the Hannibal downtown area. Mr. Yapp presented the Council with photos of properties that have been revitalized as well as houses that are in desperate need of repairs. Mr. Yapp and Mr. Wikstrom advised the Council they both would like to support efforts to encourage revitalization in the downtown district by offering advice, support, and participation in a committee to encourage development.

#### Re: Lease Agreement for American Cruise Lines Inc.

(Resolution No. 2490-23)

Lisa Peck, City Manager, advised Council the previous five-year agreement for the American Cruise Line is up for an additional five-year extension. American Cruise Line has made 113 visits to Hannibal, carried 24,000 guests, spent \$3,600.000 by docking, and docked seven different boats to the Hannibal Riverfront.

#### Re: Renewal Agreement with Open.Gov Software

Lisa Peck, City Manager advised the Council that the renewal for Open.Gov is being presented for approval. Ms. Peck advised that the software is utilized by the City's Building Inspector's Office to track and document inspections and permits, allowing permits to be applied for online, and reduced the keeping of paper records in the Inspectors Office.

#### JAMES LEMON – CITY ATTORNEY

**Re: Video Service Provider Act** (Bill No. 23-036, to follow, first reading)

City Attorney James Lemon advised the Council that the State passed the Video Providers Act to allow video service providers to be on public right-away. Mr. Lemon advised our cable provider has a franchise agreement therefore they continue to pay their franchise fee. However, when the law was written in August of this year the amount to be paid dropped from 5% to 1/2 % which will change over the next few years as well as there are ongoing lawsuits against Netflix and other video providers to see if they can be classified as this type of provider. Mr. Lemon advised that they are not a franchise therefore the City needs to change the Ordinance.

DARRIN GORDON – GENERAL MANAGER, BOPW Re: Stormwater Funding Ballot Initiative

Darrin Gordon, General Manager of the Hannibal Board of Public Works advised that at the last regularly scheduled Council meeting he, accompanied by Matthew Munzlinger, presented details regarding the funding mechanism for the stormwater ballot language. Mr. Gordon reiterated it would be a flay based rate determined by the ratepayer's meter size and usage.
