Mr. Arp advised MIRMA promotes their risk management program through newsletters, training, conferences, and on-site evaluations among other opportunities. The Hannibal Police Department applied for three Risk Management grants and was awarded a total of \$10,697.75. Mr. Arp advised the department has taken advantage of the wearable recording devices in the amount of \$7,500, non-lethal rounds in the amount of \$527.75, and car camara grant in the amount of \$3,375.
