Re: Requests, Closures - Street, Parking Spaces, City Owned Parking Lot & Use of City Owned Property

Kathy Wear, representing the Dutch Country General Store, approached Council requesting street and parking lot closures and the use of City owned property. Ms. Wear stated the Dutch Country General Store is holding the Grand Opening Celebration October $2^{nd} - 4^{th}$. On Saturday, October 3^{rd} , she would like to have a very brief antique tractor parade and show. The tractors would gather at the Admiral Coontz Armory parking lot to line-up, proceed down Warren Barrett Drive to Main Street, ending at the City owned parking lot on Main Street adjacent to the Dutch Country General Store. She is requesting to block off a few of the parking spots located in front of the store, as well as a couple in front of the Main Street Wine Stoppe, in which Paul Lewellen confirmed he has no concerns with the utilization of the spaces in front of his business during this time period. Ms. Wear is also requesting to close a portion of the City owned parking lot utilizing 10 spaces that are right next to their building. She stated the tractors will be off the property by 2:00 p.m., and estimates the tractors to be on display from 10:30 a.m. to 2:00 p.m.

Council Member Veach then joined the meeting.

City Clerk Zerbonia stated she has also been working with Ms. Wear to obtain the proper insurance certificate. Zerbonia stated the Hannibal Police Department did state that they would have to pay three officers at \$35/hour for 1.5 hours of over-time, totaling \$157.50, however, no objections from any City departments were received for this event.
