Re: Caterer's License

There have been several requests recently for individuals or businesses to obtain a caterer's liquor license. Our current ordinance requires that they only way a party can do this is if they have an existing liquor license at a location inside the City Limits. The problem with this is that the State now allows several types of caterer's license that are valid across the state (RSMo 311.486). It has as a result become evident to staff that have been refusing to allow a business license to people who have properly obtained one from the State, which could be argued to be interfering with the state liquor laws. As a result, we have drafted the attached ordinance to address the issue.
