JASON KRIGBAUM – HEARTLAND AUTOBODY Re: Request, Street & Parking Place Closures – Annual Veterans Day Parade

Saturday, November 7, 2020 – 11:00 a.m. – 12:30 p.m.

Jason Krigbaum, representing Heartland Autobody, approached Council requesting street closures for the Annual Veterans Day Parade to be held Saturday, November 7, 2020 from 11:00 a.m. – 12:30 p.m. He is requesting all side streets to be closed along Broadway from Maple Street to South Main Street, along with blocked parking for the announcer's trailer, which will be located at 4th and Broadway, the parade route will continue turning right on South Main Street, concluding at Church Street.

Mr. Krigbaum then provided Mayor Hark with the certificate of insurance and the Mayor noted other required paperwork is on file.

JAMES LEMON – CITY ATTORNEY

Re: Indian Mounds Substation Acquisition of Property – Contract for Sale of Real Estate & General Warranty Deed

Lowes Home Centers, LLC - \$40,000 (Resolution No. 2301-20, to follow)

City Attorney James Lemon, stated his first item of business is the acquisition of property designated for the new Board of Public Works substation from Lowes Home Centers. Lemon reminded Council they previously approved the Mayor to sign the proper documents, however, after the approval, Lowes representative didn't like some of the language in the documents, although they had drafted the majority of the language. Lemon advised Council the new changes do not change any terms, the price of the property or the property description. The revised documents changed minimally to suit Lowes. Lemon stated he did however, wait until he had received the revised, signed documents from Lowes before presenting to Council this evening.

Lemon stated Resolution No. 2301-20 is to follow, for approval.

Re: Police Department Anti-Crime Enforcement Squad (ACES) Training – Mutual Aid Training Agreement

City of Hannibal, Police Department (Resolution No. 2302-20, to follow)

Lemon's final item of business is an agreement for mutual aid training between the Hannibal Police Department and the Palmyra Police Department. He advised, Chief Davis and Chief Bogue have been working on an agreement to allow Palmyra officers to get "hands on" experience with our Anti-crime Enforcement Squad (ACES) unit. Lemon drafted an agreement, which states Palmyra will be liable for actions of members of their department.

Lemon stated Resolution No. 2302-20 is to follow, for approval.

Mayor Hark asked if this was presented to MIRMA, the City's liability company. Chief Davis, from the audience, stated the City of Hannibal and the City of Palmyra are both insured by MIRMA. Lemon stated he was advised by Chief Bogue that he had presented the agreement to MIRMA and there were no objections. Chief Davis advised it's not uncommon for his department to host "training" for other smaller departments and he feels this will be very beneficial for both departments.

Mayor Pro Tem Dobson questioned if this agreement was similar to the Fire Department Mutual Aid Agreements, with basically HPD having their resources available to the Palmyra PD and vice versa. Chief Davis stated the agreement was for training only purposes stating that members of ACES can train the other officers, however, Palmyra will still be liable for their own department's actions.
