TO: Hannibal City Council



Due to financial constraints over the last few years we have had to delay the purchase of computer equipment for the police department. We are in need of replacement computer equipment to enable our staff to do their jobs effectively. Our department relies heavily upon computers to accomplish their jobs and they are essential for our daily work. We need new computer equipment which not only functions better, but which is secure and reduces any security vulnerabilities.

On November 4th, 2022 the Missouri Department of Public Safety opened grant funding on their Peace Officers Grant (POG). There is \$10 million dollars allocated to law enforcement in Missouri with an award of \$20,000, requiring a 50% match. If awarded, the City of Hannibal would be required to match up to a maximum amount of \$20,000.

I am asking for the council's approval to apply for the American Rescue Plan Act Grant through the Missouri Department of Public Safety.

The Hannibal Fire Department are in need of new vehicle extrication equipment. Our department purchased our current vehicle extrication equipment between 2007-2009. This equipment has served our department well over the last 15 years but is nearing the end of its usable life.

On November 4, 2022 the Missouri Department of Public Safety opened grant funding on a Fire Protection Grant Program. There is \$10 million allocated statewide with each agency allowed up to a \$20,000 maximum award as a 50% match. The City of Hannibal would be required to match up to \$20,000 for a total of \$40,000 spent.

I am asking for the council's approval to apply for the American Rescue Plan Act Grant through the Missouri Department of Public Safety.

Our website designer must have extensive experience in creating mobile first, user responsive, search engine optimized websites specifically for tourism destinations, entities, and Destination Marketing Organizations (DMO). Our advertising directs prospective visitors to our website for tourist information. The site must be engaging, responsive and intuitive in design.

The Hannibal Convention & Visitors Bureau solicited bids from qualified vendors and received two bids; one from Maddeen Media, and one from Osborn Parr Barr Paramore (OBP), the current state division of tourism website vendor. The state vendor has already met and passed the state requirements.

The sealed bids gave tiered pricing for a new website, with options for add-ons and customized integration. Both bids gave a range in estimated pricing depending on the customizations we

After careful review of the bids, follow-up calls, Zoom meetings and emails to answer any

questions, we would like to move forward in negotiaions with OBP to finalize a contract, not to

exceed \$110,000. We will bring the contract back for council approval once it is completed and

reviewed by the City Attorney.

The state Markteting Platform Development Grant will cover 75% of the cost of the new website.

Staff recommends moving forward in the discovery phase of website development with the OBP agency, bringing back a finalized contract and resolution for the mayor to sign after discovery phase, which will allow us to have a set price, not exceeding \$110,000.
