CALL TO ORDER

MIKE MURPHY – BUILDING INSPECTOR Re: Rezoning, Southeast Corner Intersection of Munger Lane and Stardust Drive

B – *Multiple Family to E-Commercial*

It being the appointed time, Mayor James Hark called the public hearing to order regarding the rezoning of property located at the southeast corner intersection of Munger Lane and Stardust Drive. He then called Mike Murphy, Building Inspector forward. Murphy reported that a request to rezone property located at the SE corner intersection of Munger Lane and Stardust Drive was received by the City. The request asked for the property to be rezoned from B-Multi Family to E-Commercial, the property which was just purchased by the Terrill's will be used for a coffee shop and perhaps later an office. Planning and Zoning Commission approved the rezoning request.

PUBLIC COMMENTS

Mayor Hark questioned if this was in line with the current zoning. Murphy advised a street is the only thing dividing the two zones. Mayor Pro Tem Dobson advised there was one outstanding piece of information that wasn't available, and he and Mr. Terrill had a meeting with the Board of Public works about it, which is the storm drain on the property. Mr. Terrill does understand that if he moves forward with the plan, he does so at his own risk. Mr. Terrill then questioned if the easement was one hundred percent in placed, in which Dobson advised it would be once approved. Councilmember Franke questioned why this wasn't there before, in which Murphy advised it was assumed it was there, but it was not recorded that way. Murphy advised Four Points did the original platting and they had included the easement; however, it was not recorded. Murphy advised if the plat was approved it would be "approved and recorded with the easement." Councilmember Franke then asked what measures are we taking to ensure this doesn't happen in the future? Murphy advised that everyone believed the information was included, "just in this case it wasn't."

Mayor Pro Tem Dobson advised that the City cannot control what is recorded at the recorder's office. Murphy advised there is no way to know recorded information until you pull the plat to review. City Manager Lisa Peck advised the document was sent back as it was submitted, which was about a month ago in which they redid the plat with the easement. Mr. Terrill advised he went to the Hannibal Board of Public Works, and they were not interested in any solution due to the inconvenience to them having to move their building. Dobson advised there is no funding to be able to assist with this.

Shankar Terrill advised she is frustrated as they had drawn the plat with an easement and they questioned why the easement was included, Terrill advised Norm Ellebrock that the Board of Public Works had requested the easement and they had to include it for approval. Terrill spoke on not wanting any further delay but feel they didn't have any other options. Mr. Terrill advised he had contacted the Board of Public Works regarding helping them put the sewer in, he continued, and we would provide them the easement. Terrill was told they did not have any funding to do so, however, "that is not my problem."

City Manager Peck recommended that Mr. Terrill consult his attorney. Mayor Pro Tem Dobson advised there is a tap fee for sewers, and they may want to meet with them to see if it was possible to waive the fee. Terrill advised "we are giving an easement that could shut down our business or cause us to move our business in exchange for nothing.

Mayor Pro Tem Dobson advised Mr. Terrill to contact him when it's time to proceed with the sewer tap and he would assist him with meeting with the BPW.

ADJOURNMENT

There being no other comments, the Mayor Hark adjourned the public hearing.

Katy Welch representing Historic Hannibal Marketing Council, advised she is requesting street closures for the annual Living Windows and Babies in Toyland Parade to be held Saturday, December 10, 2022, from 3:00 p.m. to 8:00 p.m. Welch advised the children's walking parade down Main Street will begin at 4:00 p.m. She is requesting closure of Main Street only, with no side streets from Broadway to North Street, in addition one block of Hill Street from Main Street to the alley. Welch requested police assistance clearing cars at 3:00 p.m. as well as police escort down Main Street for the parade, in addition barricades at intersections.

Jason Krigbaum, representing Heartland Autobody, approached Council requesting street closures for the Annual Veterans Day Parade to be held Saturday, November 5, 2022, from 10:00 a.m. – 12:00 p.m., with the parade beginning at 11:00 a.m. He is requesting all side streets to be

closed along Broadway from Grand Avenue to South Main Street where the parade route will continue down North Main Street, concluding at North Street.

Mayor Pro Tem Dobson thanked Mr. Krigbaum for honoring the Veterans with the parade. He then made a motion to approve the requested street closures, for the Annual Veterans Day Parade to be held Saturday, November 5, 2022, from 10:00 a.m. – 12:00 p.m. The motion was seconded by Council Member McCoy.

APRIL AZOTEA – 323 N. MAIN STREET

April Azotea then addressed Council, regarding her parking lot request and the parking survey. Mayor Hark advised that Ms. Peck would be presenting information on this subject later in the meeting.

City Manager Peck advised they received 22 responses to the survey. She then read the survey questions with the responses. Peck advised she provided Council two pages of comments from the survey, included in the results were 22 responses, with 19 no votes and 3 yes. Council Member Franke then advised the results are not binding only a fact-finding courtesy. Council Member Franke also advised since we do have a quorum present in addition to this is the first time, he has seen the results he'd like to review the information and return to it in the future. April Azotea then questioned how the survey was done and what businesses and property owners were provided to complete the survey, as she and others did not receive one.

Ms. Peck advised she had sent the survey to the Historic Hannibal Marketing Council as well as properties owners for the CID, which includes all property owners downtown. Ms. Peck advised she would be happy to answer any questions or concerns for anyone who would like to reach out to her. April Azotea advised she believes it wasn't fair because it didn't include everyone. Peck once again advised that it did include everyone.

City Attorney Lemon advised that the council doesn't have to follow the survey. Mayor Hark advised that he agrees with Councilmember Franke that the issue would be better represented with the entire Council present. Mayor Hark then provided Ms. Azotea with a copy of the survey.

Mayor Hark declared this issue tabled until the next Council meeting to provide time for Council to review the results in addition more members to be present for a decision.

Megan Rapp, Director of Convention and Tourism advised Council she is seeking approval for the 2023 Hannibal Visitors Guide printing. Rapp explained they are requested pricing for both 100,000 and 125,000 copies. Rapp advised bids were opened on October 24, 2022, two bids were received. A bid from McDaniel's Marketing in the amount of \$42,700 for 100,000 copies and \$49,958 for 125,000 copies, in addition Poole Communications submitted a bid in the amount of \$40,921 for 100,000 copies and \$49,527 for 125,000 copies.

Rapp advised HCVB staff recommends the bid be awarded to Poole Communications in the amount of \$40,921 for printing 100,000 copies of the 2023 Hannibal Visitors Guide

Council member McCoy made a motion to approve awarding the printing of the 2023 visitor guides to Poole Communications in the amount of \$40,921. Mayor Pro Tem Dobson second the motion.
