MIKE MCHARGUE – BUILDING INSPECTOR

Re: Code Amendment Revising Chapter 29 and Chapter 32

Mike McHargue, Building Inspector, advised the Council he is requesting approval for the code changes to Chapters 29 and 32 of the City Code. Mr. McHargue advised Chapter 29 changes are in regard to the water system. The water mains must meet extension requirements of the Hannibal Board of Public Works as well as Missouri Department of Natural Resources. In addition, water mains must be designed by a licensed engineer, reviewed by the Hannibal Board of Public Works, and will need to comply with all Board guidelines and construction requirements. Mr. McHargue advised Chapter 32 is in regard to dimensional requirements such as gross tract size for initial zoning, minimum lot area, setback from streets, minimum side distance from street, and accessory buildings. This request was reviewed by the Planning and Zoning Commission on November 16, 2023, with no objections to the request.
