# SETTLEMENT AGREEMENT

This Settlement agreement is made by and among the City of Hannibal, a Missouri Municipal Corporation, hereinafter, "CITY" and Compassion Church Hannibal, a Missouri nonprofit corporation, hereinafter "CHURCH".

WHEREAS, the City of Hannibal is responsible for enforcement of certain provisions of the Missouri Clean Water Law as well as certain ordinances of the City of Hannibal relating to clean water, surface water and water runoff control.

AND WHEREAS, as a part of that responsibility CITY, is now required to enforce stormwater management plans, and as part of that enforcement it may not issue building occupancy permits to any entity that constructs new construction inside the City limits of Hannibal until they have provided and complied with a stormwater management plan.

AND WHEREAS, CHURCH, constructed a building and a parking lot within the confines of the City of Hannibal, in 2023, and provided in conjunction therewith, a stormwater management plan. However, CHURCH has failed to comply with that plan, in that they have failed to pour a concrete parking lot as set out in the plan they provided and therefore are in violation of that plan.

AND WHEREAS, as a result of the foregoing, CITY has not issued an occupancy permit to CHURCH, but CHURCH has disregarded the lack of an occupancy permit and is currently occupying and utilizing the building they constructed for worship purposes.

AND WHEREAS, the City of Hannibal has requested that CHURCH comply with the terms of their plan by building the parking lot as specified in their plans, but CHURCH has failed to do so. As a result, CITY has begun citing them for occupying a building without the appropriate permit.

AND WHEREAS, CHURCH wishes to cure their delinquency and obtain an occupancy permit, but due to financing issues are unable to complete the required work immediately.

NOW THEREFORE, in consideration of resolving this matter without the need for further legal action, and to comply with the stormwater plan of CHURCH, CITY and CHURCH agree as follows:

- 1. The provisions of this agreement shall apply to and be binding upon the parties executing this agreement, their agents, subsidiaries, affiliates, and lessees, including the officers, agents, servants corporations and any persons acting under through or for the parties agreeing hereto.
- 2. In compromise and satisfaction of the allegations or claims relating to the above-referenced

claimed violations, CHURCH agrees, without admitting liability of fault to construct a parking lot pursuant to the following Schedule:

### Phase One, 2024

By Jan 31, 2025, CHURCH will concrete the Handicap area of 20x115 to accommodate people using walkers and wheelchairs. Will put blocks for the retaining wall in from of entrance 24 blocks.

### Phase Two, 2025

By October 31, 2025, CHURCH will pour footings and a retaining wall on the left side of the parking lot 115x125.

#### Phase Three 2026

By October 31, 2026 CHURCH will pour the left area of the parking lot.

#### Phase Four 2027

By October 31, 2027, CHURCH will pour the remaining right area of the parking lot.

#### Phase Five 2028.

By October 31, 2028, CHURCH will pour the driveway out to the public street, and complete any remaining finish work on the parking lot.

- During the period of this agreement, CHURCH agrees that CITY may come on CHURCH's
  property at reasonable times to conduct inspections of the work being conducted by or for
  CHURCH.
- 4. CITY shall issue an occupancy permit to CHURCH, subject to this agreement. CHURCH agrees that if at any time they breach this agreement that at CITY's option CITY may immediately revoke CHURCH's occupancy permit. CHURCH agrees in such eventuality to immediately cease use of the property until such time as a new occupancy permit is issued. In the event that CHURCH fails to immediately cease use of the property, CITY may immediately file a petition for injunctive relief. In the event such a petition is filed CHURCH consents to and waives any objection to the entering of an order by the court enjoining CHURCH from occupying or using the property until an occupancy permit is issued, and further waive any requirement that a bond be filed by the city in order to obtain such injunctive relief. CHURCH waives trial by jury as to any issues related to this agreement, and further consents to venue and jurisdiction in the Circuit Court of Marion County, Division 2 at Hannibal, Missouri.

- 5. CITY agrees to dismiss any current enforcement actions related to lack of an occupancy permit. However, in the event that CHURCH breaches the agreement the City may immediately begin such enforcement action as they deem appropriate, in both City court and/or State Court. It shall not be a defense to any cause of action brought in City court that the City has filed a petition for injunctive relief in state court.
- 6. CHURCH agrees not to contest the validity or terms of the agreement or the procedures or circumstance underlying or relating to it in any action brought by CITY to enforce any of the terms or related matters of this agreement.
- 7. In the event that CITY files any action in state court, or has an attorney take any action on the agreement, then CHURCH shall pay all costs and a reasonable attorneys fee for any attorney representing CITY.
- 8. The terms stated herein constitute the entire and exclusive agreement of the parties hereto. There are no other obligations of the parties, express or implied, oral or written except those which are expressly set out in the Settlement Agreement. The terms of this agreement supersede any previous conversations or agreements, whether express or implied. The terms herein may not be modified except in a writing signed by all parties.

Landlord hereby grants to Tenant the Access Easement and Utility Easement described in Section 5 of this Lease.

#### 2. USE

The Premises will be used for the purpose of installing, constructing, maintaining, repairing, operating, altering, inspecting, and removing the following communication equipment:

- 2.1 Concrete pad for outdoor cabinet; dimensions 8 feet X 8 feet
- 2.2 Double bay outdoor cabinet; dimensions 78" Height X 59" Width X 42" Depth
- 2.3 2 communication antennas with transmission lines to the outdoor cabinet
- 2.4 1 3ft microwave dish with transmission lines to the outdoor cabinet

#### TOWER LEASE AGREEMENT

THIS TOWER LEASE	AGREEMENT ("Lease") is made and entered into as of the
day of	, 2024, by and between the City of Hannibal, acting by and
through the Hannibal I	Board of Public Works ("Landlord"), and Quincy/Adams County 9-1-1
("Tenant").	

For good and valuable consideration, the parties agree as follows:

#### 1. PREMISES

Landlord leases to Tenant, and Tenant leases from Landlord space for equipment on the tower (the "Tower") owned by Landlord located at 1312 Westfall Street, Hannibal, Missouri 63401 ("Property"), and space for a shelter next to the tower to house Tenant's Communication Equipment identified in Section 2 below (the Tower and the aforementioned space next to the tower shall be collectively referred to as the "Premises"). Landlord hereby grants to Tenant the Access Easement and Utility Easement described in Section 5 of this Lease.

#### 2. USE

The Premises will be used for the purpose of installing, constructing, maintaining, repairing, operating, altering, inspecting, and removing the following communication equipment:

- 2.1 Concrete pad for outdoor cabinet; dimensions 8 feet X 8 feet
- 2.2 Double bay outdoor cabinet; dimensions 78" Height X 59" Width X 42" Depth
- 2.3 2 communication antennas with transmission lines to the outdoor cabinet
- 2.4 1 3ft microwave dish with transmission lines to the outdoor cabinet

For the purposes of this Lease, all of Tenant's above-described equipment antennas, dishes, radios, lines, switches, power supplies, accessories, and all necessary appurtenances will be referred to herein individually and collectively as "Communications Facilities."

Communications Facilities may be installed on the Premises by Tenant or by any of Tenant's agents or contractors. Tenant may run transmission lines, phone lines and cables throughout the Property to connect elements of the Communications Facilities on the Premises as approved by the landlord. The tenant will provide scaled drawings to the landlord for approval.

#### 3. TERM

Landlord grants to Tenant, for use by Tenant its employees, agents and contractors, an easement and license to enter upon the Property on a twenty-four (24) hour, seven (7) days per week three hundred sixty-five (365) days per year basis, for (i) ingress and egress to and from the Premises and the Communications Facilities (the "Access Easement"), and (ii) the installation, operation and maintenance of necessary utilities for the Premises and the Communications Facilities (the "Utility Easement").

Whenever the Tenant, or a Representative of the Tenant, is onsite, the Landlord must be notified by calling (573) 221-0955.

Landlord will maintain dedicated 120-volt electric service to the Premises. Tenant will be responsible for all charges related to the electricity that they use or consume on the Premises. Upon request Landlord shall furnish such evidence as Tenant may reasonably require of the insurance including, but not limited to, a certificate of insurance.

Tenant agrees to indemnify and hold the Landlord harmless from all claims (including costs and expense of defending against such claims) arising from any of the following:

- a. breach of this Lease by Tenant;
- b. Any negligent act, negligent omission, or intentional tort of Tenant or Tenant's agents, employees, contractors, invitees, or licensees occurring during the term of this Lease, on or about the Premises;
- c. All claims, actions, proceedings, damages, and liabilities, including attorney's fees, arising from or in connection with Tenant's possession, use, and return of the leased property; and,
- d. Any damage to the property of the Tenant.

Landlord agrees to indemnify and save Tenant harmless from all claims (including costs or expenses of defending against such claims) arising from any of the following:

- a. breach of this Lease by Landlord;
- b. any negligent act, negligent omission, or intentional tort of Landlord or Landlord's agents, employees, contractors, invitees, licensees; and,
- c. Any act determined to be an act of God and renders the premises inoperable, the lease is immediately terminated
