#### **INVOCATION**

The invocation was then given by Council Member Munger.

#### PLEDGE OF ALLEGIANCE

Council Member Phillips led the Pledge of Allegiance to the Flag.

#### **APPROVAL OF AGENDA**

A motion was made by Mayor Pro Tem Dobson to amend the agenda as presented to the Council to add an item under his name to discuss vending slot machines used in locations other than the licensed gambling businesses. The motion was seconded by Council Member Franke.

A motion was made by Mayor Louderman to amend the agenda as presented to the Council to include Bill No. 24-008 as presented to include the three exclusions discussed in the Public Hearing and presented to Council. The motion was seconded by Council Member Welch.

Mayor Louderman advised the Council that no citizens registered to speak this evening.

### SCOTT BOEHMER – YMENS CLUB OF HANNIBAL Re: Street Closure/Use of City Owned Property

Scott Boehmer, representing the Hannibal Y Men's Club, approached Council requesting street closures for the upcoming Down by the River events for the following dates:

- Friday, May 17, 2024, from 4:00 p.m. until 11:00 p.m.
- Friday, June 21, 2024, from 4:00 p.m. until 11:00 p.m.

He also requested street closures for the Annual Mud Volleyball tournaments that are taking place July 3, 2024, through July 7, 2024, beginning June 30<sup>th</sup> to allow for set up ending July 7, for clean-up. Mr. Boehmer advised the closures are to begin at 7:00 a.m. on July 3, and end at 5:00 p.m. on July 7.

The street closures he is requesting for both events include the alleyway west of the Y-men's Pavilion and Hill Street from Main Street to the floodwall. Mr. Boehmer requested no bollards be used.

A motion was made by Council Member Welch to approve the requested street closures, and the use of City owned property for both events. The motion was seconded by Council Member McCoy.

Motion carried.

City Clerk Melissa Cogdal requested the Council amend the previous motion and approval to include the event insurance is pending and approval will be contingent on the provided documents. Mrs. Cogdal advised pending insurance is normal for these events due to insurance being issued closer to the event dates, as well as Y Men's Club will provide insurance documents to her in the Clerk's office closer to the event date.

A motion was made by Council Member Franke to approve the amended requested street closures, and the use of City owned property for both events pending insurance. The motion was seconded by Mayor Pro Tem Dobson.

### MICHAEL DOBSON- MAYOR PRO TEMPORE Re: City Code 17-437/Pertaining to UTV Insurance Amounts

Mayor Pro Tem Mike Dobson advised the Council he would like to discuss the City's current City code 17-437 on insurance requirements for UTV's. Mr. Dobson currently advised the policy states anyone issued a permit to operate a UTV on the City streets is required to have 500,000 liability coverage or full coverage on the vehicle. Mr. Dobson's concerns with the amounts are that full coverage depending on the liability amount would not be sufficient coverage to replace a vehicle if damaged or totaled. Mr. Dobson believes it is the City's responsibility to protect the public when policy is made, and the current policy falls short of doing so.

The Council requested information on the financial impact and different levels of coverage. Mayor Pro Tem Dobson will gather the additional information and present it to the Council later.

#### LISA PECK – CITY MANAGER Re: Revising Chapter 32- Use of Marijuana (Bill No. 24-007, to follow, first reading)

Lisa Peck, City Manager advised the Council a public hearing was held earlier in the night to discuss the changes to the Missouri Constitution which allowed recreational marijuana use. Ms. Peck advised by a vote of the people of Missouri the Constitution was amended to provide for the sale, use and possession of marijuana for recreational use. Pursuant to Article XIV of the Missouri Constitution. Therefore, the Council is revising the City of Hannibal Chapter 32 Code of Ordinances. Changes to the City Code of Ordinances will be revoking Section 32-1 and adding the new section 32-1. City Attorney James Lemon advised the change in the Constitution. Mr. Lemon advised that the vote changed the Missouri Constitution but not law or workplace policies.

Mayor Louderman advised Bill No. 24-007 to follow, for a first reading.

## ANDY DORIAN – DIRECTOR OF CENTRAL SERVICES Re: Dedication of Stormwater/ Fette Subdivision

(Bill No. 24-010, to follow, first reading)

Council Member McCoy made a motion to table Bill No. 24-010 for further review of the dedication of the Fette Subdivision stormwater infrastructure including right of ways and easements to public use to the City of Hannibal. Mayor Pro Tem Dobson seconded the motion.

### **Re: Airport Farm Lease Agreement**

(Resolution No. 2500-24, to follow, for approval)

Andy Dorian, Director of Central Services, is requesting approval of a bid award to Chase Goldinger in the amount of \$11,500 for approximately 50 acres of tillable farmland at the Hannibal Regional Airport. Mr. Dorian advised the City received three bids with Mr. Goldinger being the winning bid. In addition, the lease is for a term commencing on February 20, 2024 and expiring January 31, 2025.

Mayor Louderman stated Resolution No. 2500-24 is to follow, for approval.

McHargue reminded the Council that the current zoning of the property is D - Highway Business, and the request was reviewed by the Planning and Zoning Commission who voted unanimously to approve the request and forward to the Council for approval.

Mayor Louderman advised Bill No. 24-006 to follow, for a first reading.

#### BIANCA QUINN – FINANCE DIRECTOR Re: Budget Schedule

Bianca Quinn, Director of Finance, presented the Council with the 24/25 Fiscal Year budget schedule for approval. Mrs. Quinn advised there will be two budget workshops held this Fiscal Year, the first being on March 12<sup>th</sup> at 5:30 p.m. and the second on April 9<sup>th</sup> at 5:30 p.m. These will be held in the City Council Chambers. Mrs. Quinn asked for approval from the Council to set a public hearing on the FY 24/25 Budget on Tuesday, May 7, 2024.

Council Member Welch made a motion to approve the setting of two budget workshops and the Public Hearing for May 7, 2024 for the 24/25 fiscal year. Council Member McCoy seconded the motion.

#### **Re: Bid Limits**

(Bill No. 24-009, to follow, first reading)

Ms. Quinn's last item is regarding bid limits pursuant to Section 9.13(b) of the Charter of the City of Hannibal, which states the Council shall amend the bid limits annually. Ms. Quinn is requesting the approval of bid limits set in accordance with the National All Urban Consumers. This process is utilizing the December-to-December comparison, the index increased 3.35% from December 2022 to December 2023. Mrs. Quinn advised all purchases made under the bid limits will be substantiated by two or more quotes from reliable firms or individuals and all purchases shall be competitively shopped.

Mayor Louderman advised Bill No. 24-009 to follow, for a first reading.

#### JACOB NACKE – CHIEF OF POLICE Re: Purchase of Two CSO Officer Vehicles Joe Machens Ford (State Contract CC240138008) \$61,300.00

Jacob Nacke, Hannibal Police Chief, advised the Council he is requesting approval for the purchase of two 2024 Ford Maverick Crew Cab AWD vehicles for Community Service Officers use. Mr. Nacke advised the department currently has three Community Service Officers and two vehicles. Mr. Nacke reminded the Council the department purchased one new vehicle in 2023 however the other remaining vehicle is a Ford Transit Van with 114,000 miles on it. The department will be using State Contract for the purchase of the vehicles through Joe Machens Ford and the delivery of the vehicles will be six months. The cost of the vehicles will be \$30,650 each for a total purchase price of \$61,300 and the purchase price will be covered by savings in the current budget.

A motion was made by Mayor Louderman to approve purchase of two Community Service Officers vehicles for the total amount of \$61,300 from Joe Machens Ford. The motion was seconded by Council Member Welch.

#### **Re: Video Surveillance System Bid Award** Behl Electric and Security \$35,446.36

Nacke's last item for tonight is approval of a bid award to Behl Electric and Security for the replacement of the department's video surveillance system, co-ax wiring, and adding power over ethernet system. Mr. Nacke advised Behl was not the lowest bid however, with yearly charges it will be with service agreements calculated in. Mr. Nacke advised that due to the department being short of officers the replacement will be covered by the current budget. The total cost of the replacement will be \$35,446.36.

A motion was made by Mayor Pro Tem Dobson to approve the bid award in the amount of \$35,446.36 to Behl Electric and Security for the replacement of the video surveillance system. The motion was seconded by Council Member McCoy.
